#### Background

This was the first meeting of the Early Intensive Developmental and Behavioral Intervention (EIDBI) Advisory Group. The group was formed to advise the Minnesota Department of Human Services (DHS) on the ongoing development and implementation of the EIDBI Benefit. The benefit is for people under the age of 21 with a diagnosis on the autism spectrum (ASD) and related conditions who are eligible for or who receive Medical Assistance (Medicaid). Staff from the Disability Services Division of DHS administer the benefit.

This meeting was devoted to providing members of the group with an orientation. The orientation covered:

- Introductions of members and Disability Services staff who will work with the advisory group
- Role of the advisory group
- Principles to participate, DSD's commitment to the advisory group and visitors' information
- The EIDBI benefit, what it is, how people access it, etc.
- Current and proposed legislation that authorizes the benefit
- Future advisory group meeting schedule
- Parents' meeting. DHS plans to hold these meetings quarterly. The purpose of these meetings is to provide information on the benefit to parents, answer their questions, hear about their experiences and challenges and to provide feedback to the advisory group.

### Suggested future meeting agenda topics

DHS asked members to propose future agenda topics, which are listed below:

- 1. Outline or go through the array of services—besides the EIDBI benefit—for people with ASD and related conditions.
- 2. Create an exceptions process for enrolling new EIDBI providers.
- 3. Ensure the expedited, rapid enrollment of providers.
- 4. Review provider requirement, present and proposed.
- 5. Make assessment improvements.
- 6. Consider the financial accessibility of benefit, including TEFRA fees.
- 7. Consider how to influence private insurers to pay for the benefit.
- 8. Notice process, denial of eligibility, appeals
- 9. Integration with MnCHOICES assessment, waivers
- 10. Workshops and group homes: empower clients to supervise other clients when program lacks staff. Provide them with training and support to do this well.
- 11. Changes in private insurance, low reimbursement rates
- 12. Informing families of all services available, including school-based services
- 13. University training to alleviate workforce shortage; connect graduates and current students to market opportunities for employment.
- 14. Help undergrads to get personal care assistance (PCA) positions to fulfill their graduation requirements and to introduce them to the field and increase supply of workers.
- 15. Kids who fall through the cracks, who have cognitive deficits, but not enough to get services
- 16. Use of service animals: May they be used with this benefit? Is there funding for this?
- 17. Promote autism awareness among employers and community.
- 18. Regular (weekly?) coordination and staff meetings
- 19. Effective ways to prevent violence by clients directed against other clients
- 20. Wages: subminimum wages, ability to earn more with experience
