Welcome

Updates – Recognition of Outgoing and New Members, COVID 19 Public Health Emergency

Krista O'Connor, Director of Program Improvement

Krista expressed gratitude to outgoing members Bob Marcum, John Wust, Abdirahman Ahmed, Stephanie Schwartz, Hodan Guled and Megan Ellingson for their contributions and dedication to the committee, the Medicaid program as well as the people we serve in Minnesota. Bob was one of the founding members and both he and Hodan served two terms. Bob also conveyed his gratitude of having the opportunity to volunteer

on "the best Medicaid Advisory Committee" and has spoken to the National Association of Medicaid directors in Washington DC on two separate occasions.

Six open Member seats expired in September that include one beneficiary or caregiver of beneficiary, three non-profit, consumer group or health and human services organization and two physician or other health care professionals/providers. Recommendations have been approved by Cynthia McDonald, Assistant Commissioner HCA, and sent to Jodi Harpstead, Commissioner HCA, for final review and approval. Member appointments will be finalized and in place for the February 2023 meeting.

As of late October 2022 Krista O'Conner accepted the Director of Program Improvement position and introduced Melorine Mokri, Director Deputy Federal Relations, as her replacement. Melorine Mokri works with a team that oversees Medicaid State plan and waivers as well as negotiations with Centers for Medicare & Medicaid Services, CMS, and is looking forward to working with this committee.

Effective October 13, 2022 the US Department of Health and Human Services extended the Public Health Emergency for up to another 90 days and has pledged to give at least a 60-day notice before terminating the PHE. The end of the PHE will trigger the return to annual renewal processes for medical assistance in the Minnesota Care programs and experts agree this will create the biggest challenge to health care coverage since the implementation of the Affordable Care Act.

2023 MSAC Meetings

2023 Legislative Session Discussion

The 2023 Legislative session begins January 3, 2023. This year, 2023, is a budget year and a balanced budget must be passed and signed into law by July 1, 2023.

Draft proposals for Health Care Administration include expanding MA coverage for children, increase asset limit for MA people age 65 and older, people who are blind or have a disability, improving ways enrollees and applicants interact with our programs, additional needs for 'unwinding' from the COVID-19 PHE, expanding adult dental benefit, eliminate out-of-pocket costs for MA, remove barriers for doulas, increase Staffing in focused areas, PCA rate increases, updating competitive workforce factors, increasing hourly limits for paid parents and spouses, support people with disabilities and direct support during hospitalization, creating a discrete 'Life Sharing" benefit and increasing the rate, inflationary updates for disability waiver rate framework, behavioral

health proposals, Housing Stabilization Services (HSS) Benefit Expansion and HSS Payment Rate Update, older adults proposal, reform the EW program to allow older adult with complex behavioral health needs to access more intensive services to live in their communities, plus more.
