Updates

Governor's Budget Proposals for Minnesota Health Care Programs

Update on budget proposals: Expand the medical assistance coverage for children without having to reapply until age 6; redetermine eligibility for children ages 6-21 every twelve months; expand MinnesotaCare coverage for undocumented children; invest in the eligibility systems; Improve applications and forms so they're easier to understand and available in more languages; funding for the agency to partner with community-based organizations working directly with enrollees on program improvements; increase awareness of TEFRA option for children with disabilities. Over the next year redetermine the eligibility of all Minnesotans enrolled in our

program; streamline a process that makes it easier for all parties. Some other benefits and service items include adult dental benefit expansion, elimination of out-of-pocket costs for those on MA, remove barriers for doulas, increase our Provider Enrollment and State Medical Review Teams and extend the provisions for audio telehealth until June 2025. Minnesota Health Care Programs: Plan to Unwind Continuous Coverage

During the COVID-19 Public Health Emergency most renewals were stopped to ensure people had coverage and actions were taken that were beneficial to an individual. The number of Minnesota new enrollees has grown about 28% making close to 1.5 million enrolled in our program. With the new Federal law, Consolidated Appropriations Act 2023, it proclaims continuous coverage will end March 31, 2023, and States may begin redeterminations as early as April 1, 2023. Medical Assistance renewals occur throughout the year, MinnesotaCare renewals occur in the fall. Pillars of the unwinding plan are Program Policy and Training, Measures and Data, System Readiness, Communications and Outreach, Enrollee Support, and County and Tribal Support. One of the Legislative proposals is asking for Federal reinvestment dollars to maintain coverage and to support the unwinding to ensure Minnesotans keep coverage.

Substance Use Disorder System Reform Waiver
