- The AL Report Card was publicly launched on January 29, 2024.

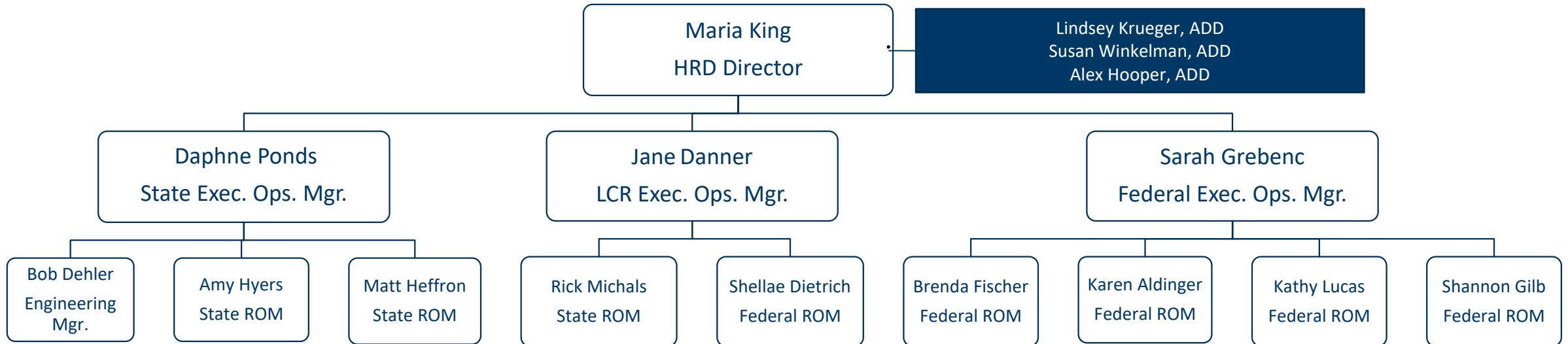

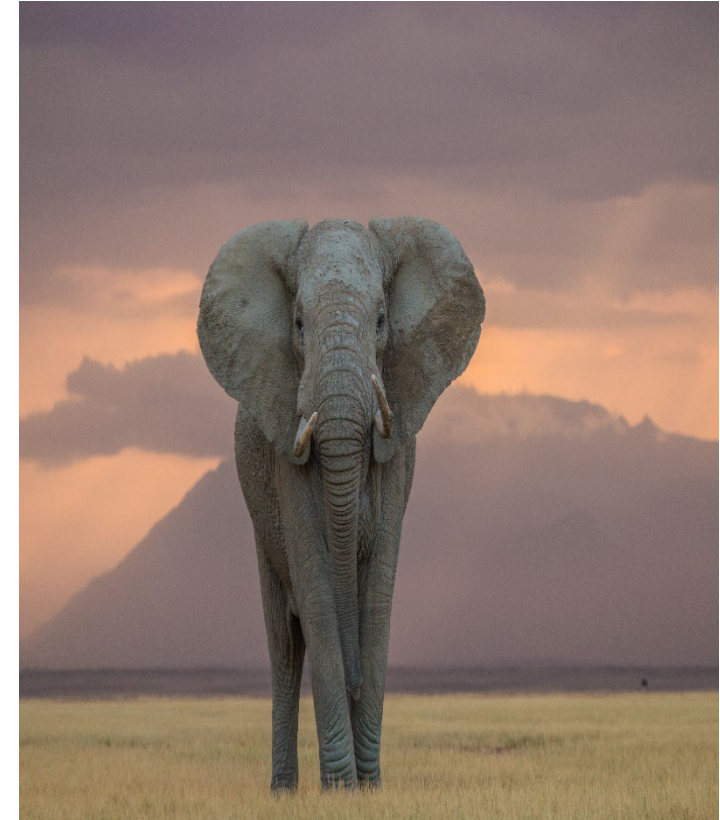

AL quality sources of data

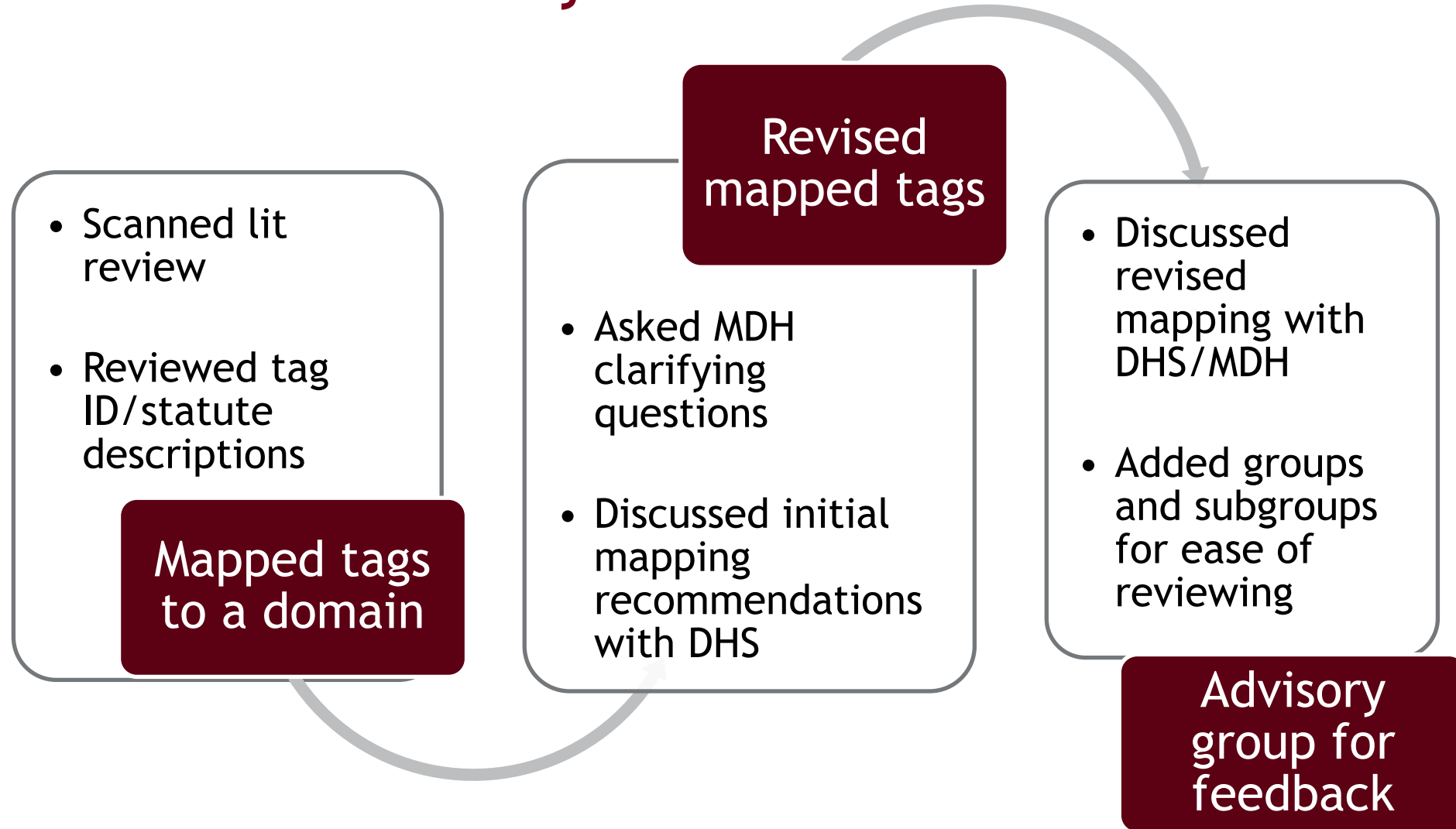
The AG extensively discussed staffing

- What are possible data sources to measure staff-related items?
- Discussed developing a staff satisfaction survey
- Covid-19 and budget concerns postponed these discussions

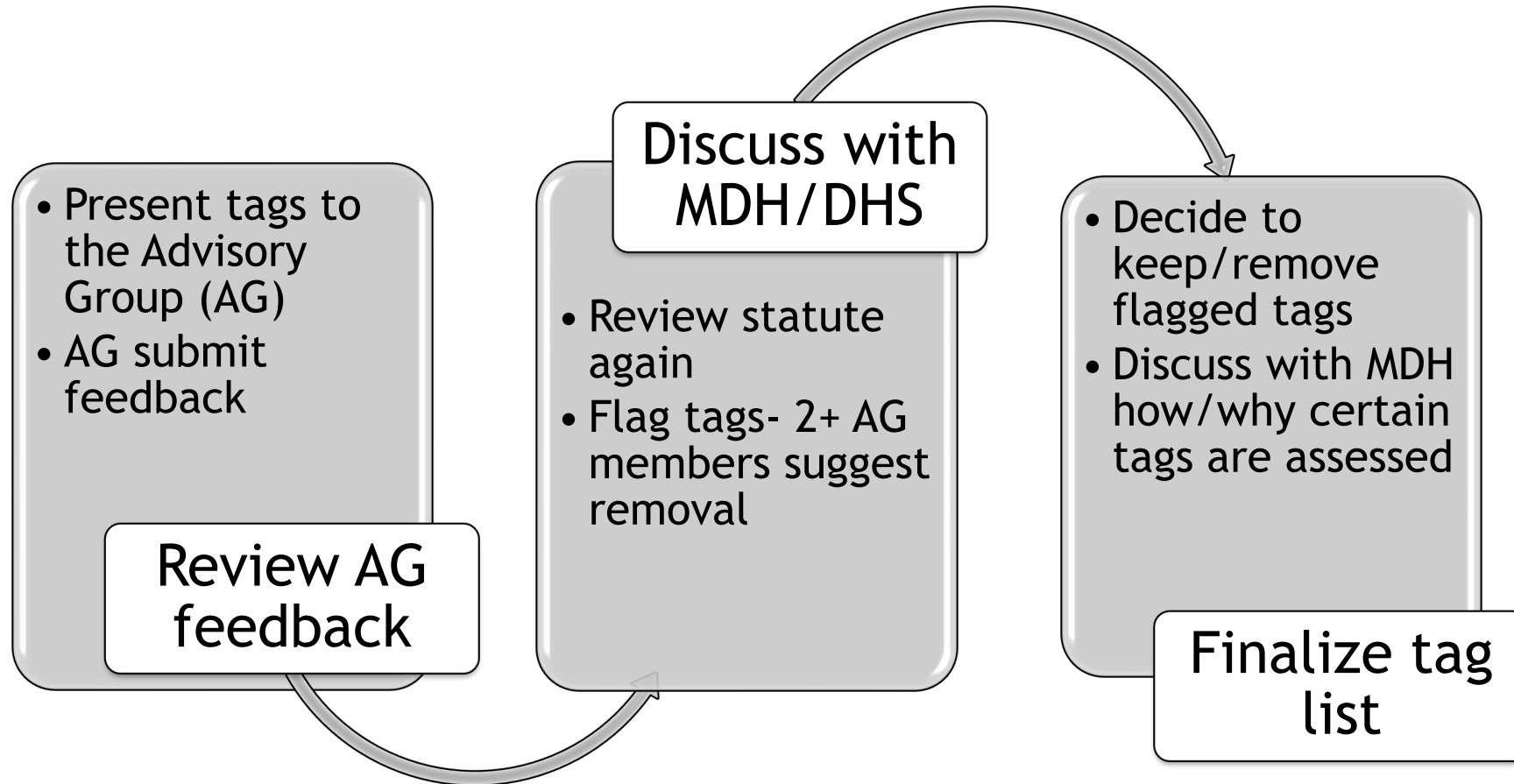
What are other exiting sources of data?

- Reviewed licensure survey letters to evaluate if they can be used to support quality measures
- Presented initial findings to the AG

Mapping tags to the staffing, resident health outcomes and safety domains

Tag inclusion-background

- First, U of MN was contracted to provide a written plan for how to operationalize three quality measures (staff, safety, and resident health outcomes) based on MDH licensure survey and investigations data. UMN findings and recommendations were then presented to DHS and AG for feedback.
- AG members who provided feedback on tags brought their own perspectives/background. For example, what some thought were tags outside the control of the AL others thought this was basic medication safety.

Summary of AG tag feedback

- Overview of reasons provided by AG members for including tags
 - Ensures safety
 - Ensure communication and follow-through on medically-significant cares, such as medication
 - Care coordination important for resident health
 - Need to alert residents/families of policies prior to implementing policies
 - Standard practice
- Overview of reasons provided by AG members for excluding tags
 - Out of the AL facility's control
 - Administrative burden
 - Doesn't pertain to all AL facilities
 - "Sub" regulation and there are other, more important tags
 - Standard practice

Tags removed and/or discussed based on AG feedback

- A handful of tags in the safety domain met removal discussion criteria
 - Three tags were removed: tags 340, 2480, & 3060
- A handful of tags in the resident health outcomes domain met removal discussion criteria- 0 were removed
 - Discussed how a number of tags are assessed by MDH, particularly for medications
- No tags met removal discussion criteria for staff domain
