

Ongoing Training Family Child Care

Minnesota law requires licensed family child care providers, second adult caregivers, adult caregivers and substitutes to take ongoing training. This training provides caregivers with knowledge and skills to provide a healthy and safe environment for the children in care. While some of the training requirement topics are specified, providers and caregivers have the flexibility to take some of the annually required hours of in-service training on a variety of different topics. As a child care provider you may want to track required ongoing training here.
