- AMHI Mental Health Federal Block Grant
 - The first funds that are set to expire 9/30/2023 are being removed from the mini-application
 - Block grant funds will now expire 3/14/2024 and 9/30/2024
 - $_{\odot}~$ The block grant funds can be spent once contracts are fully amended
 - Services provided prior to contract amendments will not be eligible for reimbursement

- AMHI EBP Inventory update Alex Meyers
 - $_{\odot}$ Poll: How have you been involved in the evidence-based practice inventory?
 - 50% helped identify practices for their AMHI
 - 25% heard about this work at previous statewide meetings
 - 25% had not heard of the project
 - Overview:
 - MMB is building an inventory of all key services offered by AMHIs
 - Identifying which services are evidence-based, community-based or theory-based
 - Project outcomes
 - Service inventory legislative requirement
 - Impact evaluation support legislative requirement
 - Additional support
 - Project timeline
 - September November: Report development, begin impact evaluation discussions,
 - develop additional next steps
 - Key takeaways
 - All AMHIs are investing in EBPs
 - 69% of AMHI grant spending was associated with at least one EBP
 - 6 EBPs are adopted by 50% or more AMHIs
 - 3 theory-based services are being used by nearly all AMHIs
 - Poll/Discussion: How has inventorying EBPs changed your perspective of evidence in AMHI

work?

- 31% responded that this is the first time they have focused on EBPs
- 31% responded that more of the services are EBPs than originally expected
- 37% responded that they were already thinking about EBPs and the results are what they expected
- EBP spending is concentrated in four services
 - Top 4 EBPs represent approximately 50% of total EBP spending
 - Case Management
 - Motivational Interviewing for individuals with SMI

- Mental Health Medication Management
- Assertive Community Treatment (ACT)
- Poll: Are you surprised by the most common EBPs identified?
 - 64% said no
 - 33% said yes
- o Poll: Is it useful to see service inventories data across AMHIs?
 - 94% said yes
 - 5% said maybe
- Cash Advances Kristine Preston
 - $_{\odot}$ DHS Behavioral Health Division is working to enhance and simplify the contracting process
 - \circ Discussed calendar year contract cycles with state fiscal year funding
 - State fiscal year: July 1 June 30
 - $_{\odot}$ By statute, AMHI funds are a Type 1 appropriation
 - Funds cannot be encumbered
 - Funds cannot carry forward
 - Quarter one expenditures paid in full
 - Cash advances reconciled in quarter two
- Overpayments Summer Harrison and Jackie Laine
 - When Q1 payment were issues in full, in addition to the cash advances already paid out, it was not initially apparent when these combined amounts exceeded 2023 awards
 - One AMHI overpayment
 - Fourteen CSP overpayments
 - $_{\odot}$ Invoices will go out the week of September 18, 2023
