The service menu reconfiguration in Waiver Reimagine Phase 1 shifted the old SLS Daily service to the new Integrated Community Supports (ICS) and has had unintended consequences for people, mostly on the DD Waiver, that were living in supported apartments. While ICS is considered a daily residential service, it's not set up for 24-hour support and it does not include nursing hours or transportation wrapped in. A person receiving ICS could purchase those outside of the ICS service through a different provider, but that serves to take huge chunks of the daily rate for providers that co-sign or guarantee the leases. With the current rate structure, providers are not finding the service to be financially viable, and some may choose to get out of the apartmeto move to a licensed CRS setting, which is less independent, and/or find a new provider, both of which are tremendously disruptive to thent programs and discharge the people they are currently supporting. This forces the people
