General summary

Westview Assisted Living is located on the Galeon Senior Living continuum of care campus in a residential neighborhood. The campus offers independent living, customized living, memory care and a skilled nursing facility. Westview Assisted Living offers customized living services for people who require supports such as medications, mobility and daily living tasks. It has 25 apartments. There currently are 22 people living there, nine of which are using services funded by the Elderly Waiver.

The campus is located in Osakis, Minnesota. Osakis is located in the west-central part of the state and is a rural area. Most of Osakis is located in Douglas county, though a small part extends into Todd county. The population was 1,740 as of the 2010 U.S. Census.

Customized living provider standards/qualifications

Licensure requirements and other state regulations for customized living services clearly distinguish these services/settings from institutional licensure or regulations.

Customized living services are provided in housing-with-services establishments with the service provider directly licensed as a comprehensive home care provider by the Minnesota Department of Health. Customized living services provide an individualized package of regularly scheduled health-related and supportive services provided to a person who resides in a qualified, registered housing-with-services establishment.

Customized living service definitions that support the setting requirements

Customized living (CL) and 24-hour CL services include component services designed to meet the person's assessed needs and goals. Individualized CL services may include supervision, home care aide tasks (e.g., assistance with activities of daily living), home health aide tasks (e.g., delegated nursing tasks), home management tasks, meal preparation and service, socialization, assisting people with arranging meetings and appointments, assisting with money management, assisting people with scheduling medical and social services and arranging for or providing transportation. If socialization is provided, it must be part of the service plan, related to established goals and outcomes and not diversional or recreational in nature.


Meaningful distinction between the facility and HCBS setting

Each customized living setting has its own director (Housing Director) and its own clinical director, who is a registered nurse and manages the home care program of business. The management of the customized living settings, including Westview, have no management responsibilities in the skilled nursing facility. The skilled nursing facility has a separate director of nursing who does not have management responsibilities of the customized living settings.
⊠Met □Unmet □Not applicable	To the extent any facility staff are assigned occasionally or on a limited basis to support or back up the HCBS staff, the facility staff are cross- trained to meet the same qualifications as the HCBS staff; (staff training materials that speak of the need to support individuals' chosen activities), (person centered planning) (the staff is trained specifically for home and community-based support in a manner consistent with the HCB settings regulations.) The staff at the skilled nursing facility do not work or provide services at the Westview customized living setting. This was stated by both the administrator and the staff person interviewed. They both also stated that if a skilled nursing facility staff person wanted to work at Westview, the person would receive HCBS training as part of the Westview orientation/training.
⊠Met □Unmet □Not applicable	Participants in the setting in question do not have to rely primarily on transportation or other services provided by the facility setting, to the exclusion of other options; (Describe the proximity to avenues of available public transportation or an explanation of how transportation is provided where public transportation is limited.) People living at Westview have several options for transportation. Rainbow Rider is the public transit option in their area. Westview also

	has accessible buses, and there are community volunteer drivers who drive the buses and provide rides to people at Westview. Many people have family that transports them as well. People can ask the director or any staff to help them arrange transportation using one of the above options. Transportation information is posted on bulletin boards

Community engagement opportunities and experiences

People living at Westview have many options to experience their community. When people move in, they are asked about their activity interests. In addition, in monthly tenant meetings, people are encouraged to give feedback on new events or activities they would like to see offered in the future. People are made aware of their choices of activities through calendars, television screens throughout the building, bulletin boards and table tents in the dining room. People living in Westview can choose to attend activities with the skilled nursing facility, independent living building or the other customized living setting. Some examples of community activities that have been offered are:

- Attending Osakis Days
- Boat rides
- Fishing
- Going to garage sales
- Holiday lights tours
- Trips to Tip Top, a local restaurant
- Community bingo
- Sporting events, such as Lynx games
- Parades
- Salad luncheons
- Attending a 5K and BBQ
- Trailer rides.


People also experience the community with their families and friends when they take them on car rides, lunches/dinners, family events or other activities of interest. People go shopping, get their hair done or attend religious services.

A daycare brings children to visit the campus, and various musicians come to perform.

The setting has activities on site as well, such as arts and

crafts, bingo, religious services and events on the patio. Some people enjoy gardening during the summer. The setting also hosts an event where people can wear their prom or wedding dresses or just show them to others.

There is an expansive wellness center, Club Galeon, which the public can use to exercise or swim. A person interviewed said using the pool was one of her favorite things.

People in the setting were observed using their keys to get into their apartments. In addition, staff were observed knocking before entering a unit. A person interviewed answered, "Very much!" when asked if staff respect her privacy.

A person interviewed talked about the items in her apartment and said, "I have all the things that I said that I couldn't live without, like photos and sentimental things".

Staff interviewed said if a person misses a meal, a plate will be saved if he/she requests it. Also, a person may request a snack at any time. and it will be provided to them. In addition, people have kitchens for food storage in their units. A person stated she feels she can get food at any time, adding, "That's why I've gained five pounds".

Public comment summary

The Minnesota Department of Human Services (DHS) did not receive public comments for this setting.

DHS sought public comment for 30 days (Feb. 6-March 7, 2019) before submitting settings to the Centers Medicare & Medicaid Services (CMS) for heightened scrutiny.

We sought public comments using the following methods:

- Evidentiary packages posted online on the <u>Home and Community Based Services Rule</u> <u>transition plan page</u>
- Evidentiary packages specific to each setting posted in a common area of the setting
- Notice of public comment period via Feb. 6, 2019, eList announcement
- Notification to lead agencies via regional resource specialists
- Notification to providers via email
- Notification to managed care organizations and Area Agencies on Aging (AA) via email
- Notification to long-term care ombudsman office via email
- Disability Hub MN virtual insight panel.

Minnesota's recommendation

Date of recommendation: 4/1/2019

Minnesota supports that this setting overcomes the institutional presumption and meets the requirements of a home and community-based setting. Provider is required to maintain on-going compliance with all HCBS requirements.
