INTRODUCTION

The Annual Synar Report (ASR) format provides the means for states to comply with the reporting provisions of the Public Health Service Act (42 U.S.C. 300x-26) and the Tobacco Regulation for the Substance Abuse Prevention and Treatment Block Grant (SABG) (45 C.F.R. 96.130 (e)).

How the Synar report helps the Center for Substance Abuse Prevention

In accordance with the tobacco regulations, states are required to provide detailed information on progress made in enforcing youth tobacco access laws (FFY 2019 Compliance Progress) and future plans to ensure compliance with the Synar requirements to reduce youth tobacco access rates (FFY 2020 Intended Use Plan). These data are required by 42 U.S.C. 300x-26 and will be used by the Secretary to evaluate state compliance with the statute. The information to be reported is public (45 CFR 96.130 (f)) and is not confidential. Part of the mission of the Center for Substance Abuse Prevention (CSAP) is to assist states¹ by supporting Synar activities and providing technical assistance helpful in determining the type of enforcement measures and control strategies that are most effective. This information is helpful to CSAP in improving technical assistance resources and expertise on enforcement efforts and tobacco control program support activities, including state Synar program support services, through an enhanced technical assistance program involving conferences and workshops, development of training materials and guidance documents, and onsite technical assistance consultation.

How the Synar report can help states

The information gathered for the Synar report can help states describe and analyze substate needs for program enhancements. These data can also be used to report to the state legislature and other state and local organizations on progress made to date in enforcing youth tobacco access laws when aggregated statistical data from state Synar reports can demonstrate to the Secretary the national progress in reducing youth tobacco access problems. This information will also provide Congress with a better understanding of state progress in implementing Synar, including state difficulties and successes in enforcing retailer compliance with youth tobacco access laws.

Where and when to submit the Synar report

The ASR must be received by SAMHSA no later than December 31, 2019 and must be submitted in the format specified by these instructions. Use of the approved format will avoid delays in the review and approval process. The chief executive officer (or an authorized designee) of the applicant organization must sign page one of the ASR certifying that the state has complied with all reporting requirements.

The state must upload one copy of the ASR using the online WebBGAS (Block Grant Application System). In addition, the following items must be uploaded to WebBGAS:

- FFY 2020 Synar Survey Results: States that use the Synar Survey Estimation System (SSES) must upload one copy of *SSES Tables 1–8* (in Excel) to WebBGAS. Please note that, beginning with the FFY 2019 ASR, SSES will generate Tables 6, 7, and 8, which are based on the <u>optional</u> microdata on product type, retail outlet type, and whether identification was requested. If your state does not submit these optional data, Tables 6, 7, and 8 will be blank. Tables 6, 7, and 8 are generated for the convenience of the state, and states are <u>not</u> required to submit completed versions of Tables 6, 7, or 8. 



MN. Statute 461.12, subd. 5 states; "A licensing authority shall conduct unannounced compliance checks at least once each calendar year at each location where tobacco is sold to test compliance with section 609.685." However, Over 80 percent of respondents (136) who answered the question indicated they checked every retailer. Out of the 29 respondents who answered "no," 10 said their agencies were not responsible for conducting the checks. Seven respondents cited a lack of resources or available staff and time to perform checks.

Merchant education and/or training

The Minnesota Department of Human Services facilitated the tobacco merchant education program Congratulate and Educate. The program goals are to implement tobacco merchant education and increase the number of tobacco compliance checks across the state of Minnesota. In 2019, out of the 87 counties in the state of Minnesota, 48 participated. Overall, 70 agencies from police departments, sheriff's offices and public health departments participated in the initiative, conducting 1,472 educational tobacco compliance checks. The number of counties participating increased by one this year but the number of checks went down slightly. DHS also has prevention grantees which have a multi-area focus including tobacco prevention. DHS also funds the Waybinagay Program which is a culturally specific smoking prevention and cessation program for Native American youth and young adults.

The Association for Non Smokers-Minnesota, with assistance from the Public Health Law Center and support from the Minnesota Department of Health, developed an online merchant education and training program, which was implemented two years ago. It is a free comprehensive, online training that covers state & federal laws regulating the sale of tobacco, electronic cigarettes and tobacco-related devices. This training template allows ANSR to observe and interact with the merchants who have completed the training. Postcards highlighting this new online training tool were created and made available to all tobacco merchants in the state.

The Minnesota Department of Health has Statewide Health Improvement Partnership (SHIP) grantees who are working throughout the state to create healthier communities by striving to reduce the harms from tobacco. One initiative is to work with merchants on Point of Sale education. They also promote the DHS Congratulate & Educate program while interacting with tobacco merchants.

Incentives for merchants who are in compliance (e.g., non-enforcement compliance checks in which compliant retailers are given positive reinforcement and noncompliant retailers are warned about youth access laws)

Through the DHS Congratulate & Educate Program the retailers or clerks receive a certificate and positive reinforcement if they pass the compliance check. Through the DOH online merchant education and training program participants receive a certificate of completion.

Community education regarding youth access laws

Both the Minnesota Department of Human Services tobacco merchant education program, Congratulate & Educate, and the Minnesota Department of Health's online merchant education and training program, educate both clerks and owners on Minnesota and Federal youth access laws.

Media use to publicize compliance inspection results

Many local communities report their annual tobacco compliance check results in public meetings and/or in the local news. Local public health & state partners educate the community about youth access to tobacco and local compliance check results on their websites.

Community mobilization to increase support for retailer compliance with youth access laws

The Minnesota Department of Human Services communicates with Police Chiefs and County Sheriffs emphasizing the importance of enforcement of state and local tobacco access laws through the Synar Tobacco Enforcement survey. Minnesota Department of Human Services partners with Police, Sheriff and Public Health departments to conduct the Congratulate and Educate tobacco merchant education project.

Adult Inspectors are current Minnesota Department of Human Services staff who are Commissioned Officers of the Federal Department of Health and Human Services. Our FDA inspectors complete the FDA Inspector training program and are employed full time. They have been conducting inspections since the inception of the FDA Tobacco Program in MN. The Synar inspections are conducted by the FDA inspectors in the same manner that FDA requires with the exception of the specific product purchased consistently and the specific age required by the Synar protocol of 16.

Minors are recruited by state staff to conduct FDA inspections. They are trained with the FDA minor training and on the job training with the Program Coordinator and adult inspectors.

The adult inspector is to enter the establishment prior to the youth to assess the safety of the environment. They are not to leave until the youth has safely left. Minors have a key to the vehicle so they can let themselves in and lock the door if necessary prior to the adult inspector arriving back at the vehicle. Minors do not use ID's as a safety precaution, so retailers do not have access to their name and address.

A stratified simple random sampling method was used with two strata (urban and rural). The sampling unit was Census Tract. Out of 1,335 census tracts, 44 tracts were randomly selected: 24 from urban stratum and 20 from rural stratum, following the guideline provided by SAMHSA.

There were two strata: urban and rural.

The urban stratum was defined as the seven counties including the Twin Cities (Minneapolis and St. Paul) metropolitan area and the surrounding counties. This is a standard convention for Minnesota. The seven counties (Anoka, Carver, Dakota, Hennepin, Ramsey, Scott, and Washington) cover 704 census tracts (53% of the state total).

The rural stratum covers the remaining 80 counties in Minnesota with 631 census tracts (47% of the total).

If the property was closed at the time the canvassing team visited it, the team would return to it later when it was open. Inspectors entered every site which they identified as possibly selling tobacco. Once inside the inspector did a visual scan of the establishment to determine if tobacco was sold. In cases where no tobacco was observed, the inspector asked staff if they sold tobacco.

11. Please provide the state's definition of "matches" or "mismatches" to the Synar sampling frame? (e.g., address, business name, business license number)

To determine match vs. mismatch, both the address and business name were compared between the log form completed by field staff and the most recent list frame.

If both name and address matched, they were marked as a match.

If the address matched but the business name was changed and it was clear that the new business was selling tobacco products, it was marked as a match and the list frame was updated. For example, a Superamerica was changed to Speedway at the same address.

If there was some discrepancy in the address between the log form and the list frame, but even with the difference, the field inspector could have easily found the outlet with the information on the list frame, such as business name with city and zip code and/or phone number, the case was marked as a match. For example 9646 Main St. vs. 9646 Main St. E. with the same business name (Captain Blacks Bar & Grill). This kind of minor discrepancy could be easily resolved by inspectors with an online search and/or a phone call.

If the discrepancy is more substantial and it would be likely to cause trouble for the field inspector to locate the business, then the case was marked as a mismatch.

If the outlet found was a new site, it was marked as a mismatch and the site was added to the list frame.


