# 2023 Session Preview

- The 2023 legislative session begins January 3, 2023.
- All 67 seats in the Senate and all 134 House seats are up for election, as is the Governor.
- 2023 is a budget year, and a balanced budget must be passed and signed into law by July 1, 2023.
- The results of today's elections, as well as the November budget forecast, are the next big steps in the proposal development process.



- All of the proposals we are highlighting today are considered **DRAFT**.
  - These proposals are still under discussion and consideration.
- No decisions have been made yet about what will be in the 2023 Governor's budget, nor is this a comprehensive list of items the agency is considering.



# **Eligibility and Enrollment**

- Expanding Medical Assistance coverage for children
  - Let children on Medical Assistance stay on the program without reapplying until age 6.
  - Let children ages 6-21 on Medical Assistance only have their eligibility redetermined every 12 months.
- Increasing the asset limit for MA for people age 65 and older and people who are blind or who have a disability

# Eligibility and Enrollment (continued)

- Improving the ways applicants and enrollees interact with our programs
  - Improving the language accessibility of applications and forms, including making them easier to understand and available in more languages.
  - Making it possible to report any changes to enrollees' information and upload documents online, instead of having to mail them or contact the county.
  - Making it possible for enrollees to receive notices electronically, instead of in the mail.
  - Improving the access that enrollment assisters, like navigators, have to information about the enrollees they are helping, so they can better help when enrollees have problems or questions.
  - Providing funding so DHS can partner with community-based organizations to work more directly with enrollees and use the information we learn to make additional program improvements.
- Additional needs for "unwinding" from the COVID-19 public health emergency

# **Benefits and Services**

- Expanding the adult dental benefit
- Eliminate out-of-pocket costs for everyone on Medical Assistance when they go to the doctor or the pharmacy
- Remove barriers for doulas to provide care
- Increasing staffing for both our Office of the Managed Care Ombudsperson and the State Medical Review Team (SMRT)

# Disability Services, Behavioral Health, and Housing

# **Disability Services Proposals**

- PCA/CFSS rate increases
- Increasing rates for the Positive Support Services to better attract professionals to offer the service
- Updating the competitive workforce factor for unit-based services in the disability waiver rate system
- Aligning disability homemaker rates with the homemaker rates in the Aging programs to create parity
- Increasing the hourly limits for paid parents and spouses for Community-First Services and Supports (CFSS) and Consumer-Directed Services and Supports (CDCS)
- Supporting people with disabilities and direct support professionals during hospitalization by reimbursing for certain personal care assistant (PCA) and waiver services
- Studying the possibility of moving respite, positive support services, and specialist services into a 1915i state plan authority to increase access
- Creating a discrete "Life Sharing" benefit and increasing the rate, while aligning Family Residential Service rates with a person's assessed support needs

# **Disability Services Proposals (continued)**

- Rate Increases for Intermediate Care Facility for people with Developmental Disabilities (ICF/DD). This proposal would establish a rate floor and provide biennial inflationary updates.
- Inflationary Updates for Disability Waiver Rate Framework. This proposal modifies the timing of Bureau of Labor Statistics inflationary updates and uses newer data to calculate the updates. It also modifies the timing of Consumer Price Index updates to better allow rates to keep pace with inflation.

# **Behavioral Health Proposals**

- Adult Day Treatment Rates. This proposal increases ADT rates by 50%.
- **Comprehensive Assessments.** Expand the provider types that can provide MA substance use disorder assessments.
- MA SUD Demonstration Waivers. Administrative funding to develop the internal infrastructure to expand the current 1115 SUD waiver to include: traditional healing, behavioral health services in jails/prisons, and contingency management.
- **SUD Evidence-Based Treatment.** Requires all MA SUD providers to meet American Society of Addiction Medicine criteria by 2025.
- OTP payment integrity. This provision breaks apart the current OTP daily bundle and separates the drug component from the rest of the OTP services. The new payment method includes a weekly drug bundle and non-medication components (substance use counseling, individual and group therapy, and toxicology testing).

# Housing Proposals

- Housing Stabilization Services (HSS) Benefit Expansion. This proposal provides ongoing funding for HSS moving expenses to continue beyond March 2024, when the federal temporary funding ends.
- Housing Stabilization Services (HSS) Payment Rate Update. This proposal adds an inflationary increase to Housing Stabilization Services rate every two years, based on the consumer price index, allowing services to keep pace with inflation.



# Older Adults Proposals

- Rate increases for the Elderly Waiver, Alternative Care, and Essential Community Supports programs. This proposal increases the home and community-based service rates delivered under the EW, AC, and ECS programs. It also establishes a biennial inflationary updates under the Elderly Waiver.
- **Consumer-Directed Consumer Supports (CDCS) parity.** This proposal provides an increase to monthly budgets for people using the CDCS option under EW and AC.
- Older Adults with high support needs due to complex behavioral health conditions. This proposal would reform the EW program to allow older adults with complex behavioral health needs to access more intensive services in order to live in their communities.
