Use updated form to report provider organization change in ownership

Minnesota Health Care Programs (MHCP) has published a new version of the <u>Provider Entity Sale or Transfer Addendum</u> (<u>DHS-5550</u>) (<u>PDF</u>). This is a form that is required along with other enrollment documents when an enrolled MHCP provider undergoes a change in direct or indirect ownership of the business.

The new form covers more circumstances of ownership change, and allows for multiple transferors and transferees to sign. Starting on **February 1, 2023**, MHCP will no longer accept the prior version of the form. The new version with the date 12-22 in the upper right corner is the only version that will be accepted for changes in ownership.

MHCP needs to be notified of changes in ownership at least 30 days before the date of ownership transfer. Grants available for HCBS providers supporting rural and underserved communities

The Minnesota Department of Human Services (DHS) is offering Provider Capacity Grants to organizations serving, or looking to serve, home and community-based services (HCBS) to rural and underserved communities. The program is intended to increase the number of HCBS providers throughout Minnesota and the number of HCBS providers providing culturally specific services.

Grants of \$100,000 - \$250,000 are available to organizations to expand their ability to provide services to older adults and people with disabilities in rural and underserved communities. The State is particularly interested in organizations serving people with complex needs, the LGBTQ+ population and organizations providing language supports and culturally specific services.

Applicants who are eligible for the grants include:

- Organizations who want to become an HCBS provider for the first time
- Existing HCBS providers who want to expand their existing services to reach more people, or develop, become
 licensed and enroll with DHS to deliver a new service

Nonemergency Medical Transportation (NEMT) drivers must enroll by Jan. 1, 2023, to avoid denied claims

NEMT drivers must be enrolled with Minnesota Health Care Programs (MHCP) by Jan. 1, 2023, to avoid denied claims. Transportation agencies can enroll drivers with Minnesota Health Care Programs (MHCP) through either one of the following ways.

- Use the Minnesota Provider Screening and Enrollment (MPSE) portal: Log into your transportation organization's account and select Manage Organization to Individual Affiliations. Follow the instructions in the Organization to Individual section in the MPSE User Manual to enroll the individual driver.
- Fax required documents to MHCP: Complete the following enrollment forms and fax to MHCP at 651-431-7462.
 - o Individual Provider Enrollment Application (DHS-4016) (PDF).

- Note: Under the Individual Provider Personal Profile section, fill in the Background Study Number or Request ID (NEMT Drivers only) field with the <u>NETStudy 2.0</u> background study number or request ID for individual NEMT driver.
- Individual Non-Pay-To Provider Agreement (DHS-4611A) (PDF).

All providers should review and keep a copy of the Data Privacy Notice (DHS-6287) (PDF).

On July 1, 2021, Minnesota legislation began requiring all NEMT drivers to enroll with MHCP and affiliate with a transportation organization by July 1, 2022. MHCP began enrolling NEMT drivers July 1, 2021.

Early Intensive Developmental Behavioral Intervention (EIDBI) policy change to coordinated care conferences

Minnesota Department of Human Services (DHS) has received approval from the Centers for Medicare & Medicaid Services to implement the recent legislative change that no longer requires the qualified supervising professional to be present at coordinated care conferences. This change is effective July 1, 2022. Review Minnesota Statutes 256B.0949 for more information about the change.

DHS views a coordinated care conference as best practice to ensure a person with complex health needs has access to and receives appropriate medically necessary care. A coordinated care conference is a voluntary meeting to review treatment plan goals, review progress monitoring updates and coordinate services across providers. A coordinated care conference does not require authorization and can be provided as medically necessary. The conference must include the person's caregiver or legal representative or the person receiving EIDBI services.

Providers eligible to bill for this service and the following may participate in the coordinated care conference:

- Personal care assistance or direct support workers
- Family members or other primary caregivers
- Licensed professionals who work with the person or family or whose services may be needed (for example, mental health, speech therapist, occupational therapist, social worker, and so on)
- School personnel
- Case managers or care coordinators
- Other providers, advocates or individuals the family requests

New substance use disorder (SUD) screening available effective Jan. 1, 2023

Minnesota Department of Human Services (DHS) is implementing a new SUD screening called Screening, Brief Intervention, and Referral to Treatment (SBIRT) effective Jan. 1, 2023.

SBIRT is an early intervention approach used to identify people with substance use disorders as well as those who are at risk of developing these disorders. SBIRT is used to reduce and prevent substance use disorder through the use of screening tools, brief interventions, and, if needed, a referral to treatment.

The following enrolled Minnesota Health Care Programs (MHCP) providers are eligible to provide SBIRT:

- Advanced practice registered nurses
- Clinical nurse specialists
- · Licensed alcohol and drug counselors
- Licensed independent clinical social workers
- Licensed marriage and family therapists
- Licensed professional clinical counselors
- Licensed psychologists

- Nurse midwives
- Nurse practitioners
- Physician assistants
- Physicians
- Psychiatric nurse practitioners
- Psychiatrists
- · Tribal certified professionals

The SBIRT HCPC procedure codes effective Jan. 1, 2023, are G2011, G0396 and G0397.

SBIRT will be available for Medicaid-only members. Eligible members may receive six hours of SUD services without a comprehensive assessment, depending on the results of the screening. The six hours of SUD services include:

- 4 hours of individual or group treatment; and
- 2 hours of treatment coordination or peer support

The Behavioral Health Division will offer informational sessions about SBIRT in the coming weeks, and we will add a SBIRT section to the MHCP Provider Manual.

Authorization requirement start date for outpatient nonresidential Substance Use Disorder providers delayed

Nitrous oxide covered as a dental service for non-pregnant adults

Effective Sept. 1, 2022, one unit of nitrous oxide, CDT code D9230, is allowed per member per day in conjunction with a covered dental service for non-pregnant adults enrolled in Minnesota Health Care Programs (MHCP).

Minnesota Department of Human Services is aware of claims denying with CDT code D9230 and is currently working on our internal system to resolve this issue. Continue to submit claims for this service as usual.

We will post another message on this webpage to notify providers when we have resolved this issue. After it is resolved, you will be able to re-submit any denied claims for services with CDT code D9230 provided on or after Sept. 1, 2022.

Service limit and authorization requirements removed from EIDBI treatment planning and progress monitoring

Minnesota Department of Human Services (DHS) recently removed all service limits from the Early Intensive Developmental and Behavioral Intervention (EIDBI) Individual Treatment Plan (ITP) planning and progress monitoring code H0032 with the UB modifier. Refer to the Individual treatment plan (ITP) development and progress monitoring policy manual webpage. Providers can now utilize the ITP development and progress monitoring service as clinically necessary for each individual member. The service remains as an encounter unit that can be billed one time per day, per provider, per member.

DHS also removed the service authorization requirement. Providers can submit claims to the member's corresponding health care plan without prior authorization. All services must continue to be medically necessary and meet all required service standards outlined in the <u>Individual treatment plan (ITP) development and progress monitoring</u> policy manual webpage and documented in the member's health service record.

These updates are reflected on the <u>EIDBI Billing Grid</u> and <u>EIDBI Provider Manual</u>. Refer to the <u>MHCP Fee Schedule</u> for the most current rate information. (pub. 11/8/22)

New health plan options will be available in many counties across the state in 2023

New contracts between the Department of Human Services (DHS) and the health plans participating in public health care programs will begin in January 2023. The health plan options in each county are available on the <u>Annual Health Plan Selection</u> webpage.

As a result of the new contracts, Blue Plus, Medica, PrimeWest and UCare will serve more Minnesota families and children in Greater Minnesota. UnitedHealthcare – MN will now serve St. Louis County in addition to the metro area. HealthPartners is reducing its service area for families and children and Special Needs BasicCare (SNBC), leaving several counties in Northern Minnesota. Providers can find a list of contacts for each health plan on the Managed Care Organization contacts for MHCP providers webpage.

DHS sent out annual health plan selection notices in October to current managed care enrollees notifying them of the options in their counties and how to select a health plan.

The latest contracting process prioritized efforts to address equity, eliminate health disparities, and meet the needs of rural Minnesotans. DHS and counties collaborated on the development of the questions included in the <u>procurement</u> request for <u>proposals</u>. The health plans submitted proposals responding to those questions which DHS and counties then reviewed and scored.

The Minnesota WIC program infant formulas contract changed to Enfamil milk-based formulas effective Oct. 1, 2022.

Minnesota WIC will offer store brand and Similac substitutes for Enfamil products through Dec. 31, 2022, due to nationwide formula supply concerns. Minnesota WIC participants should refer to the Minnesota WIC Enfamil Formula Substitutions list which was revised effective Oct. 29, 2022, to review allowable substitutes. Minnesota WIC encourages participants to purchase Enfamil products with their formula benefits whenever possible.

U.S. Department of Health and Human Services (HHS) extends the federal COVID-19 public health emergency

HHS Secretary Xavier Becerra renewed the federal COVID-19 public health emergency effective Oct. 13, 2022. Visit the HHS' Renewal of Determination That A Public Health Emergency Exists webpage to read the official declaration of this renewal.

Continue following existing COVID-19 policies and procedures for Minnesota Health Care Programs until further notice. We will provide more guidance as it becomes available. (pub. 10/14/22)

Federal Medical Assistance Percentage (FMAP) increases for claims paid in new federal fiscal year, COVID-19 FMAP percentage continues

Beginning with claims paid on or after Oct. 1, 2022, coinciding with the beginning of the federal fiscal year until the end of the federal fiscal year 2023 (Sept. 30, 2023), regular FMAP increases from 50.51% to 50.79% (1905(b) of Social Security Act).

Since Jan. 1, 2020, until the end of the quarter the COVID-19 federal public health emergency ends, the Families First Coronavirus Response Act (Public Law No. 116-127, section 6008) provides a temporary increase of 6.2% in the FMAP rate for the following services for children, parents or guardians with children under 19, individuals 65 and older and individuals blind or disabled:

- Individualized Education Program
- Rule 5 Children's Residential includes Institutions for Mental Disease, which receives an increase in state funds
 equal to the federal fund increase.
- County-provided Targeted Case Management services (Child Welfare, Mental Health and Vulnerable Adult-Developmental Disability)

The 6.2% COVID-19 FMAP increase and the Federal Fiscal Year FMAP increase to 50.79% does not apply to adults without children whose eligibility was gained under the Affordable Care Act and some other populations already receiving an enhanced FMAP.

Counties and providers do not need to do anything to receive the increased FMAP. Claims paid from Oct. 11, 2022, until the end of the quarter the COVID-19 federal public health emergency has ended (defined by federal government) will be paid at the higher 56.99% rate. If the COVID-19 federal public health emergency ends before Sept. 30, 2023, the percentage paid will be 50.79%.

Minnesota Health Care Programs Provider Manual webpage issues

We made an update on Sept. 27 to the web platform that houses the MHCP Provider Manual and it caused some formatting and spacing issues, as well as other unexpected behavior, on some provider manual webpages.
