Minutes

Welcome: Chair Dan Stein, Chair Call to order Roll call for committee and guests present

Reviewed agenda

Approved May minutes – Motion to confirm minutes by Amy Burt, seconded by Claudia Thomas. Verbal vote approved May minutes.

Background: Diogo Reis, Director of Health Improvement and Benefit Design division, DHS Provided summary of questions the committee is being asked, reviewed the presentations and other information shared with committee over the prior meetings on this topic.

Discussion and voting: Chair Stein

Chair Stein stated committee following Roberts rules loosely, explained utilization of poll feature for voting recording, and reviewed previous recommendations reached.

- 1. Committee recommends to not add age criteria for breast removal surgery
- 2. Committee recommends to not add hormone criteria for breast removal surgery for adults or adolescents.

Committee began discussion of outstanding questions.

- 3. Should MHCP require hormone therapy prior to breast augmentation? And if so, what is the appropriate length of time?
- A Follow current MHCP policy
- B WPATH recommendations 9 Votes from Scott Hegstad, Amy Burt, Rick Printon, Samba Fall, Rakesh John, Claudia Thomas, Sagar Dugani, Dan Stein, Saudade SammuelSon.
- C Endocrine Society
- D Other

The committee had a short discussion on variables between MHCP and WPATH recommendations and chose to vote.

Unanimous vote for option B – WPATH Recommendations from Scott Hegstad, Amy Burt, Rick Printon, Samba Fall, Rakesh John, Claudia Thomas, Sagar Dugani, Dan Stein, Saudade SammuelSon.

Recommendation reached: To follow WPATH recommendations for hormone therapy prior to breast augmentation.

- 4. Should there be age criteria for genital surgery? And if so, what age criteria? Committee and members of the public discussed scope of practice, continuing education for gender affirming providers, and benefits and barriers to receiving genital surgery prior to age 18. Amy Burt made a motion to add option D, which was seconded by Claudia Thomas.
- A Follow current MHCP policy 0 Votes
- B WPATH recommendations 1 vote from Samba Fall
- C Endocrine Society 0 Votes
- D WPATH standards except for age 18 for phalloplasty 9 Votes from Saudade SammuelSon, Daniel Stein, Howard Fink, Sagar Dugani, Claudia Thomas, Rakesh John, Rick Printon, Amy Burt, Scott Hegstad.

Recommendation reached: To follow WPATH recommendations except for age 18 for phalloplasty.

5. Should MHCP have criteria around members living in their gender role prior to gender affirming surgery? And if so, what criteria?

The Committee and members of the public discussed the language of WPATH recommendations, including discussion about what 'over time' meant, as well as the safety concerns for some trans people living in their gender role.

- B WPATH recommendations 10 votes from Saudade SammuelSon, Daniel Stein, Howard Fink,
 Sagar Dugani, Claudia Thomas, Rakesh John, Rick Printon, Amy Burt, Scott
 Hegstad and Samba Fall.
- C Endocrine Society 0 Votes
- D Other 0 Votes

Recommendation reached: To follow WPATH recommendations for gender role prior to affirming surgeries.

6. Should MHCP require letters of recommendation prior to gender affirming surgery? If so, how many and from whom?

Because end of the meeting was nearing – motion was made to split this question into two, vote on the first part presently, and move discussion on how many letters and from whom to the next meeting. Claudia Thomas made a motion to vote to on MHCP requiring 1 letter prior to gender affirming surgery. Motion was seconded by Saudade SammuelSon.

Motion passed by unanimous verbal vote.

Recommendation reached: To require 1 letter of recommendation prior to gender affirming surgery. further discussion will continue for specifications at following meeting.
