INTRODUCTION

The Annual Synar Report (ASR) format provides the means for states to comply with the reporting provisions of the Public Health Service Act (42 U.S.C. 300x-26) and the Tobacco Regulation for the Substance Abuse Prevention and Treatment Block Grant (SABG) (45 C.F.R. 96.130 (e)).

How the Synar report helps the Center for Substance Abuse Prevention

In accordance with the tobacco regulations, states are required to provide detailed information on progress made in enforcing youth and young adult tobacco access laws (FFY 2023 Compliance Progress) and future plans to ensure compliance with the Synar requirements to reduce youth and young adult tobacco access rates (FFY 2024 Intended Use Plan). These data are required by 42 U.S.C. 300x-26 and will be used by the Secretary to evaluate state compliance with the statute. Part of the mission of the Center for Substance Abuse Prevention (CSAP) is to assist states¹ by supporting Synar activities and providing technical assistance helpful in determining the type of enforcement measures and control strategies that are most effective. This information is helpful to CSAP in improving technical assistance resources and expertise on enforcement efforts and tobacco control program support activities, including state Synar program support services, through an enhanced technical assistance program involving conferences and workshops, development of training materials and guidance documents, and onsite technical assistance consultation.

How the Synar report can help states

The information gathered for the Synar report can help states describe and analyze substate needs for program enhancements. These data can also be used to report to the state legislature and other state and local organizations on progress made to date in enforcing youth and young adult tobacco access laws when aggregated statistical data from state Synar reports can demonstrate to the Secretary the national progress in reducing youth and young adult tobacco access problems. This information will also provide Congress with a better understanding of state progress in implementing Synar, including state difficulties and successes in enforcing retailer compliance

The ASR must be received by SAMHSA no later than December 31, 2023 and must be submitted in the format specified by these instructions. Use of the approved format will avoid delays in the review and approval process. The chief executive officer (or an authorized designee) of the applicant organization must sign page one of the ASR certifying that the state has complied with all reporting requirements.

The state must upload one copy of the ASR using the online WebBGAS (Block Grant Application System). In addition, the following items must be uploaded to WebBGAS:

- FFY 2024 Synar Survey Results: States that use the Synar Survey Estimation System (SSES) must upload one copy of SSES Tables 1–8 (in Excel) to WebBGAS. Please note that, in the FFY 2024 ASR, SSES will generate Tables 6, 7, and 8, which are based on the optional microdata on product type, retail outlet type, and whether identification was requested. If your state does not submit these optional data, Tables 6, 7, and 8 will be blank. Tables 6, 7, and 8 are generated for the convenience of the state, and states are not required to submit completed versions of Tables 6, 7, or 8. Merchant education and/or training

The Minnesota Department of Human Services facilitates the tobacco merchant education program Congratulate and Educate. The program's goals are to implement tobacco merchant education and increase the number of tobacco compliance checks across the state of Minnesota. DHS also has prevention grantees which have a multi-area focus including tobacco prevention. DHS also facilitates the Waybinagay Program (which means "to release or let go of" in Ojibwe). The program is aimed at preventing Twin Cities Native American youth ages 11 to 26 from using commercial tobacco products, alcohol, marijuana, and other drugs. The program utilizes an eight-session curriculum that blends cultural traditions with contemporary best practice approaches to preventing ATOD problems and is followed up by a cultural practices group.

The Association for Nonsmokers-MN (ANSR), with assistance from the Public Health Law Center and support from the Minnesota Department of Health (MDH), developed an online merchant education and training program, which was implemented six years ago. It is a free comprehensive, online training that covers state & federal laws regulating the sale of tobacco, electronic cigarettes, and tobacco-related devices. This training template allows ANSR to observe and interact with the merchants who have completed the training. Postcards highlighting this new online training tool were created and made available to all tobacco merchants in the state.

One of the focuses of the MDH grantees is implementing Point of Sale strategies. The activities include modernizing local licensing ordinances to include stronger licensing requirements such as mandatory training, higher license fees, and additional compliance checks.

Incentives for merchants who are in compliance (e.g., nonenforcement compliance checks in which compliant retailers are given positive reinforcement and noncompliant retailers are warned about youth and young adult access laws)

Through the DHS Congratulate & Educate Program the retailers or clerks receive a certificate and positive reinforcement if they pass the compliance check. Through the MDH

online merchant education and training program participants receive a certificate of completion.

Community education regarding youth and young adult access laws

Both the Minnesota Department of Human Services tobacco merchant education program, Congratulate & Educate, and the Minnesota Department of Health's online merchant education and training program, educate clerks and owners on state and federal youth access laws.

Media use to publicize compliance inspection results

Many local communities report their annual tobacco compliance check results in public meetings and/or in the local news. Local public health & state partners educate the community about youth access to tobacco and local compliance check results on their websites.

Community mobilization to increase support for retailer compliance with youth and young adult access laws

The Minnesota Department of Human Services communicates with Police Chiefs and County Sheriffs emphasizing the importance of enforcement of state and local tobacco access laws through the Synar Tobacco Enforcement survey. Minnesota Department of Human Services partners with Police, Sheriff, and Public Health departments to conduct the Congratulate and Educate tobacco merchant education project. DHS also sent a letter to all Law Enforcement agencies in the state to remind them of the requirement and the importance of conducting tobacco compliance checks at every retailer in their jurisdiction. Since the creation of the 2016–2021 Minnesota Comprehensive Tobacco Control Framework, the Minnesota Department of Health and its partners have strengthened local and state policies, secured new funding, and developed a statewide infrastructure for cessation and commercial tobacco treatment services, and provided innovative communitylevel support. For example, 24.5% of all Minnesotans are protected by local laws that prohibit the sale of flavored tobacco.

MN passed the Freedom to Breathe Act, implemented 10/01/07, restricting smoking in public places.

Continued compliance checks in counties and municipalities as per state law.

Continued Department of Human Services Synar tobacco compliance checks using FDA inspectors.

Continued Department of Human Services FDA undercover buy compliance checks.

Continued survey of enforcement agencies to access tobacco violation activity.

Conduct the "Congratulate & Educate" educational compliance check program where local law enforcement and/or public health agencies are incentivized to conduct educational tobacco compliance checks and tobacco merchant education.

Limited resources for law enforcement of youth and young adult access laws

Among the responding agencies, 13 percent or 16 agencies stated they were unable to check every retailer. Out of the 16, seven said inadequate staffing and resources prevented them from conducting some or all their checks. Other less frequently cited reasons included retailers not being open during enforcement checks, not having conducted checks by the time of the survey, and a lack of violations.

Limited resources for activities to support enforcement and compliance with youth and young adult tobacco access laws

One agency mentioned a lack of motivation to carry out enforcement checks and attributed it to the absence of compensation for these efforts.

Limitations in the state youth and young adult tobacco access laws

Limited public support for enforcement of youth and young adult tobacco access laws

Limitations on completeness/accuracy of list of tobacco outlets

Limited expertise in survey methodology

Laws/regulations limiting the use of minors in tobacco inspections

Difficulties recruiting youth and young adult inspectors

It is difficult recruiting and retaining an adequate number of underage purchases given the need for employees across all hiring platforms and the competitive wages being offered by other businesses.

Issues regarding the balance of inspections conducted by youth inspectors age 15 and under

It is difficult maintaining a comparable male/ female ratio given the complications associated with maintaining the underage purchaser workforce during Synar.

Adult Inspectors are current Minnesota Department of Human Services staff who are Commissioned Officers of the Federal Department of Health and Human Services. Our FDA inspectors complete the FDA Inspector training program and are State of Minnesota employees. They have been conducting inspections since the inception of the FDA Tobacco Program in MN. The Synar inspections are conducted by the FDA inspectors in the same manner that FDA requires with the exception of the specific types of product purchased consistently and the specific age of underage purchasers as required by the Synar protocol of 17-20 years of age.

Procedurally adult inspectors are instructed that the inspection should not be conducted if the adult or youth inspector perceive the site as unsafe. The adult inspector is to enter the establishment prior to the youth to assess the safety of the environment. They are not to leave until the youth has safely left. Underage purchasers have a key to the vehicle so they can let themselves in and lock the door, if necessary, prior to the adult inspector arriving back at the vehicle. Underage purchasers do not use ID's as a safety precaution, so retailers do not have access to their name and address.

All youth inspectors are trained in a face to face virtual training facilitated by the Program Coordinator and complete the FDA Minor Inspector Training prior to conducting Synar inspections.

The MN Synar Protocol was revised, with approval in 2015 to use only 16 year old youth for the Synar inspections. The Protocol was again revised and approved in 2017 to allow the youth to request newly deemed tobacco products, including e-cigs and cigarillos.

The MN Synar Protocol was revised in 2020 to use 16 & 17 year old youth to be in compliance with the newly revised MN State laws listed above (16 year olds were included because 16 year olds had already conducted Synar inspections prior to the state statute requiring youth to be at least 17). We also revised the protocol to allow the youth to request the "types" of products rather than the specific "brands" of products.

The MN Synar Protocol was revised in 2021 to include 17-20 year old youth to comply with the new MN laws listed above.
