

Themes

- Strengths
- Format limitations and tradeoffs

- Suggestions

Strengths

- Passionate, dedicated group of WRAC members
- Lots of useful expertise: lived experience, direct services, managerial, system perspective, etc.
- Opportunities for improvement of the waiver system
- Members feel WRAC should continue

Format limitations and tradeoffs

Challenge	Benefit
Large group size is difficult to navigate	Helpful to have a wide range of perspectives involved
Virtual is challenging	Virtual is more accessible
Bimonthly, two-hour sessions is not much time	Time commitment is doable; not everyone could spend more time on WRAC activities
Length of time between meetings → difficult to keep pace with everything that is going on and maintain momentum	Time commitment is doable

Collaboration

- Concern that there is not a genuine interest by DHS in acting on concerns/ideas from WRAC members.
- Not all members feel free to voice their views. Concerned that they will be disparaged by other members.
- Concern that too much time has been spent on airing grievances and not enough time spent on problem solving.
- Has felt divisive at times.
- Sense that the group needs a significant reset to feel productive again.
- Most agreed that facilitation has not been the issue.

Facilitator suggestions

- Mental reset + collaborative problem-solving training (OCDR could provide)
- One in-person meeting focused on relationship building
- Possible changes to meeting structure:
 - Subgroup meetings between bimonthly meetings
 - Split into topic areas groups and do work independently and then reconvene
 - Longer bimonthly meeting, with WRAC member led sections
- > Tri-chairs of WRAC members to help craft agendas

Goals of Waiver Reimagine

Better Access & Flexibility

- Simplify information about services and the process to apply for services so a person and their family can understand, describe and get the services they need.
- Provide complete, accurate and accessible information about all available services, allowing a person to make informed choices and decisions while planning services.

Equitable Access

• Each person across the state, regardless of their county or tribal nation, can access services and funding equitably and eliminate discrepancies based on their disability type or diagnosis.

Self Direction

• Increase self-directed, informed choices and decision making that allows a person who chose consumer-directed community support (CDCS) to have better control by deciding to self-direct all, some or none of their services.

Phase One - complete



Common service menu across all waivers

Phase Two – in progress



Two waiver system based on where a person lives and not on their diagnosis




A known and transparent budget based on a person's assessed needs




Informed decision making and increase flexibility to self-direct


