Review DHS' draft legislative proposal related to Minn. Stat. 256B.439

- DHS is seeking to clarify its authority to receive basic contact information for residents and residents' primary family contacts in order to conduct resident and family quality surveys
- This authority is needed to support the Nursing Home Report Card as well as the forthcoming Assisted Living Report Card

Review DHS' draft legislative proposal related to Minn. Stat. 256B.439

• Minn. Stat. 256B.439

Subd. 3c. Contact information for consumer surveys for nursing facilities and home and community-based services.

For the purposes of conducting consumer surveys, the commissioner may request client and associated key representative contact information and providers must furnish the contact information available to the provider.

Review: Phase 1

- Literature review
 - 1. Peer-reviewed (e.g. Ovid Medline, CINAHL) 49 references
 - 2. Grey literature 45 references
 - State reports, state and national AL associations, AL community opeds



Updated literature review process and results

Updated AL quality literature review by domain (20)

- Resident quality of life (9)
 - mood, cognitive health, physical activity, using technology
- Resident health outcomes (9)
 - falls
- Resident and family satisfaction (3)
 - cost of care
- Service availability (1)

- Physical and social environment (1)
 - walkways
- Care services and integration (2)
 - HIT
- Core values and philosophy (1)
- Safety (1)
 - citations



COVID-19 themes (6)

- Strategies to reduce COVID-19 transmission within AL communities Resident health outcomes
 - Early surveillance to identify **asymptomatic** residents
 - Social distancing, Early isolation policies and adherence to CDC guidance
 - Reduced contact with health care providers
- Approach to mitigating the impact of social distancing, self quarantine and isolation (staff, resident quality of life)
 - Use of holistic approaches by nurses to mitigate the impact of quality of life and wellness of residents due to social isolation
 - Staff driven interventions to maintain social connections, interactions, mentation, function and mobility among residents



Staff quality sub domains

- "Staffing is one of the most universally agreed upon domains of quality in long-term care and should be collected in some way." **Technical expert panel participant**
- Staff quality is multidimensional and needs to include perspectives of staff, residents and family members. Facilities also have a role in reporting staff quality.

Measures of staff quality

- Person-centered approaches to staff quality
- Staff empowerment
- Collaboration among staff
- Communication (among providers/direct care workers)
- Burnout/stress
- Supports (institutional, supervisor, emotional, coworker)
- Job satisfaction
- Resident-centered job satisfaction among staff



Staff quality sub-domains, cont.

- Staff turnover
- Staff training
- Consistent assignment
- Employee qualifications
- Staffing ratios
- Retention of direct care staff
- Compliance with staff training requirements



Indicators to measure person-reported domains

- Person-Directed Care (PDC) and Environmental Support for PDC measure
- Person-Centered Practices in Assisted Living questionnaire (PC-PAL)
- "Staff Experience working with Demented Residents"
- Job Attitude Scale (JAS)
- Work Stress Inventory
- CoreQ-staff*



Indicators to measure staff quality, cont.

- Observable Indicators of Quality-Assisted Living
- Nurse/staff availability (RN Hours)*
- Dementia care quality indicators
- Staff Performance Reviews*
- Staff training
