General summary

Ecumen Detroit Lakes Day Club is a program offered in a residential neighborhood, on the Ecumen Detroit Lakes community of care campus. Ecumen Detroit Lakes Day Club provides physical, social and spiritual care, to older adults and people with disabilities.

Detroit Lakes is a rural town, located in Northwestern Minnesota. Detroit Lakes' population is 9,165 per the 2016 census.

This setting reported they are serving 14 people with services funded through various pay sources, including waiver funding, veteran's services and private pay. The average number of people attending the program per day is nine. The majority of people attend the program from 11:00am -2:00pm. The setting is open Monday - Friday (8:00am-3:00pm) and night services are also available.

Adult day provider standards/qualifications

Licensure requirements and other state regulations for adult day services clearly distinguish these services/settings from institutional licensure or regulations.

Adult day services provided in center-based facilities are directly licensed by the Department of Human Services. Adult day services serve functionally impaired adults on a regular basis for periods of fewer than 24 hours during the day in a setting that is not a residence.

Adult day service definitions that support the setting requirements

Adult day services must:

- Be based on the person's assessed needs
- Be directed toward the achievement of specific outcomes identified in the person's support plan
- Offer opportunities to participate in community groups (e.g., senior citizen centers or clubs, generic service organizations, adult education)
- Provide age-appropriate tasks and materials
- Provide community integration opportunities to enhance the person's social and physical interaction with people without disabilities
- Provide the supports necessary either to maintain or improve the person's ability to care for him or herself.

Ecumen Detroit Lakes Day Club is a designated area on the ground floor of the community wellness building on the Ecumen continuum of care campus (highlighted in yellow). The adult day program location is accessible through the main entrance of the facility and then taking an elevator down to the ground floor. An orange arrow shows the walkway/lobby that is located between the adult day location and the Emmanuel nursing facility area (circled in red.

The adult day program is also accessible through two other doors on the ground level that are more utilized by participants and public transportation (indicated by red stars on the on aerial phots).



The Ecumen Detroit Lakes Day Club area is used exclusively by the adult day program, however, the adult day program has access to the campus amenities as a whole.

Community engagement opportunities and experiences

The local Detroit Lakes' community is an active social community with frequent community events. The Ecumen Adult Day Club's programming is integrated into the happenings that occur in the local area and participate in community events at various intervals, depending on the weather, but can be up to three times per week and less if the weather is not accommodating.

The Ecumen Adult Day Club does have a scheduled monthly calendar of activities, however, every morning, the people attending the program enjoy listening to the local radio station while eating breakfast and if they hear of an community event or activity that they would like to attend, the program is flexible enough that they may change the calendar for that day and do the activity the group had heard on the radio. For example, the day before the HCBS onsite visit, the temperature was unusually warm, so people attending the program choose to change their activity that afternoon to go to the local Dairy Queen for ice cream.

Other community activities people attending the adult day program have attended include classic car shows, the annual summer street fair, frequent walks to McDonald's, the local high school jazz band concerts, events in the local city park, musical performances and activities arranged by the larger community of care campus, watching the cloggers dance performance and shopping at rummage sales. People in the program enjoy going to movies, eating out, fishing and pontooning on the lake. In the winter, the program took people to the lake and viewed the famed lighted ice castle. Being a community that includes large areas of farm land, one of the activities they enjoy is going to the Steam Thresher's Reunion at Rollag, MN.

The Ecumen Adult Day Club also provides activities in the building. Staff and people in the program report that they do have the option not to attend the community events, however that does not occur frequently. Some examples of activities provided within the adult day program include baking treats, making root beer floats, playing games such as cards and bingo. The people interviewed stated they enjoyed the wood working activities the most. They build bird houses, bird feeders, and wood flower decorations. They also have raised flower beds outside the program and they are anticipating planting flowers soon.

There is a child care program that integrates their programing with the adult day program. The children in the child care come to the adult day site and utilize the outdoor area for play and interaction with the people in the adult day program. The program is aware the children are coming to the site the day after our site visit, so they are baking cookies today to have treats for the children tomorrow.

People also have the option to participate in individual activities. For example, one of the gentlemen in the program enjoys attending the local Parkinson's support group on his own. Others enjoy the campus on their motorized scooters and visiting with others throughout the campus. The men in the program report that they enjoy playing horse shoes outside as well.

Public comment summary

The Minnesota Department of Human Services (DHS) did not receive public comments for this setting.

DHS sought public comment for 30 days (Feb. 6-March 7, 2019) before submitting settings to the Centers Medicare & Medicaid Services (CMS) for heightened scrutiny.

We sought public comments using the following methods:

- Notification to long-term care ombudsman office via email
- Disability Hub MN virtual insight panel.
