How to apply for grants offered by the Minnesota Department of Human Services Disability Services Division



The Minnesota Department of Human Services Disability Services Online Grant System

Disability Services offers an online application and grant management process for the Innovation Grants. The online program keeps application and grant information available and accessible to you anytime. Applicants are able to save and access their applications as many times as needed until they hit the SUBMIT button. The program is also a resource for tracking your application status and, if awarded, managing your grant, submitting reports and communicating with your DHS grant coordinator.

This guide will walk you through the steps to set up an account so you can apply for grants electronically.


Step 1: Go to the website



Use a web browser (e.g. Chrome, Firefox, Internet Explorer) to go to the <u>Disability Services Online Grant System logon page</u>. If this link doesn't work, type or cut and paste the website address: https://www.grantinterface.com/Home/Logon into the address bar of your browser.

Step 2: Create an account

Logon Page



In order to apply online, you must first create an account.


- To create a new account, click on "Create New Account" and fill in your information, as requested.
- If you already have an account with DHS Disability Services, enter your email address and password. Click the "Log On" button to go directly to the "Apply" page.

Step 3: Enter organization contact information

An organization may be a business, nonprofit, government or university. If you are a small-scale operation or individual without a formal organization, you may use your personal contact information.

Fill in the blanks with your organization's contact information. Note: Items with an asterisk (*) are required fields.

When you are finished, click the "Next" button located on the bottom right corner of the page.




Step 4: Enter user contact information

The "User" is the person responsible for applying for the grant. Enter the user contact information into the form. Remember that items with an asterisk (*) are required fields.

Note: The email address you use on this page is the email address that must be used every time you log on to the Disability Services Online Grant System.

When you are finished, click the "Next" button located on the bottom right corner of the page.



From this point on, please do not use the browser "Back" button.

If you attempt to navigate to the previous section by using the "Back" button, you will lose all registration information entered. If you need to return to a page, click on the "Previous" button located on the bottom left corner of the page. To continue, press the "Next" button located on the bottom right corner of the page.

Step 5: Enter Executive Officer contact information




This page will ask if you are the executive officer. The executive officer is generally the person who oversees the day-to-day operations of your organization. If you are a small-scale business or individual, list the individual most responsible for the running of your operation.

- Click "Yes" if you, the User, are the executive officer then click the "Next" button located on the bottom right- corner of the page. The system will copy your user information into the executive officer form.
- Click "No" if someone else in your organization is the executive officer then click the "Next" button on the bottom right corner.
- Enter the contact information for your organization's executive officer.

Note: Entering this information does not create a separate account for the executive officer. The information is simply added to your Organization Summary page.

When you are finished, click the "Next" button.



Step 6: Create an account password

This page will ask you to create a password for your account. You will need this password every time you log on to the Disability Services Online Grant System.

Passwords must be at least six characters long and may contain only letters, numbers and certain symbols.

Enter a password in the first box; then enter it again in the second box to confirm that your entry is correct. Click the "Create Account" button located on the bottom right corner of the page.

You will receive an email message confirming that you set up the account.



Step 7: Confirm account creation

Check your email inbox for the confirmation message from the Minnesota Department of Human Services – Disability Services (DSD.Innovation@state.mn.us). If you don't see one, check your spam and junk mail folders.


- Select the "I have received the email" button if you received the confirmation email, then click the "Continue" button located on the bottom right corner of the page.
- Select the "I have not received the email" button if you did not receive the confirmation email, then click the "Send Email Again" button in the lower right corner of the page to repeat this step.
- Select the "Continue without checking" button only if you are sure that you entered the correct user email.

Click the "Continue" button in the lower right corner of the page.

Step 8: Log in to your dashboard

Each time you log in, you will be directed to your dashboard page, which includes your contact information and a number of links. This will be your go-to site throughout the process for information and updates on your application.

Check to see that your contact information is correct.



Step 9: Apply for grants

On your dashboard, click on the Apply button at the top of the page. This will bring you to the page where you can begin an application.

On the Apply page, under the search box, you will see a listing of grant programs currently available through the DHS Disability Services Division (the visual shows just one). Find the grant for which you want to apply. Once you've found it, click on the "Apply" button to the right of the listing to start your application.



Some RFPs will have a two-part process:

- 1) Letter of interest (LOI)
- 2) Application

The LOI is a shorter form to solicit idea(s) from the community. If the LOI is selected to go to the next round, the applicant will be invited to submit an application.

Both the LOI and the application forms have instructions that are specific to those forms. Be sure to read the instructions and review the entire form before beginning.
