- IV. Claudia Daml introduces Elliot Butay, Sr. Policy Coordinator from NAMI to give legislative introduction and update 11:15 12:00 (11:06)
 - Hoping this information will be helpful for new members
 - Elliot is on the Mental Health Legislative Network
 - Shares slides: Policymaking 101; some may already know this info
 - Each state has unique government which share same basic structure of Senate, house and Exec Branch (Governor and state agencies = upper chamber)
 - Senate = upper chamber w 67 members serving 4 year terms and representing a larger number of people
 - Lower chamber = House with 134 members serving 2-year terms
 - Bill introduction involves authors and co-authors; submits to Revisor who writes actual end-stage bill
 - Bills are read into chamber's official record and assigned a bill jacket with places for signatures of sponsors (authors); can have several co-authors
 - Then bill is dropped to Senate or House
 - Then referred to a committee after a floor session when a number is assigned
 - Committee members, chair, staff and testifiers are involved in the process to pass a bill
 - Committees will be set up by majority part to have more votes from majority party
 - This year was unique for MN with tie of members
 - Supreme court ruled needed 68 people for quorum and votes
 - Leadership of Sen/Hs determine who sits on which committee which are set for biennium; first year is budget cycle and second year is policy and bonding
 - Amendments will be made in committee and be voted on
 - Process can be watched via YouTube
 - Not every bill gets a hearing
 - Can be open call for public testimony
 - If bill gets votes to pass, can go to next committee
 - Bills must pass through multiple committees based on subject areas
 - Any bill costing money must go to the finance committee
 - Each section of government has a finance committee

- Each chamber has a final finance committee; in the House, this is the Ways and Means Committee
- Full chamber vote involves all members of the chamber
- Bill is debated, amended and voted on
- Jargon
 - Bills can be passed to another committee, laid over or passed to full chamber
 - Laid over means it's staying within the committee for more vetting for inclusion in the Omnibus bill where several bills are combined together
 - Can be placed on general register = full floor for vote
- Budget
 - Today is budget forecast from MMB with larger deficit (\$6B) than anticipated
 - Governor and Sen Majority Leader and Speaker negotiate agree budget targets for each committee (typically in March/April); this follows what Governor has published in January as preferred budget
 - MN requires having a balanced budget
- Omnibus bills are a vehicle to pass bills more easily
 - Will have own number so previous bill numbers will be subsumed into new #
 - House and Senates can have different priorities reflecting different priorities
- Conference Committee
 - In order to proceed to Governor, House and Senates bill must agree and be identical
 - If chambers don't agree they will assign 3-5 members each to negotiate a final bill in Conference Committee which can last several days
 - These negotiations often happen behind closed doors
- Bill goes to Governor's desk
 - Can sign, veto or line-item veto spending issues only
- Implementation
 - By government agencies such as DHS and MDH for mental health issues
 - Agencies convert law into programs and services
 - It's helpful for advocates to follow up with agencies on implementation
- Judicial branch
 - Must be lawyer to get things done in this system
 - Very slow process
 - Can declare a law unconstitutional in which case it must go back to be revised to meet criteria
 - Can involve consent decrees or fines for non-compliance
- Questions?
 - Cici: how does a bill get a sponsor?
 - A: legislative session starts in Jan/Feb and need a sponsor early on (fall) which
 can be challenging; voting cycles can also impact who is in seats; lobbyists
 have time and energy to talk to all legislators; people can go through their
 legislators;



- Legislators sit on different committees so it's helpful to know what committees your legislator sits on
- Legislators can present a bill to a committee they don't sit on; may depend on whether they're in the majority/minority party
- Bi-partisan support can be helpful to getting bill passed
- Can work with legislator on writing language
- Claudia thinks this topic could be expanded on to explore deeper advocacy work in future meetings
- Claudia: how much information would someone need to give a legislator for them to author a bill?
- A: lobbyists have the advantage of being involved in the process and doing research on these topics; an individual constituent can approach their representative
- The more information provided the better depending on their familiarity with an issue
- NAMI and staff researchers are able to help with the process
- Claudia: dates are important to know these cycles; what dates are important for readings?
- A: deadlines are set by leadership
- Typically 3: 1st to be heard in committee, 2nd is to be heard favorably in other body; companion bills have to be tracked; 3rd deadline is for budget
- 1st and 2nd deadlines this year are both April 4th (not uncommon) and April 11th which were published last week
- These deadlines are typically March/April
- Much work can happen after Omnibus bills have been drafted
- Claudia: how long does conference committee take?
- A: 3rd deadline is for hearing by finance committee and involve amendments if needed
- Omnibus floor hearing comes before a bill is assigned to conference sessions before session end
- Claudia: This group's goals are to support recommendations so it's helpful to best understand the process and be able to interact appropriately
- Jode: individual bills vs omnibus bills; is there a better process to be slid into omnibus or to be laid over or passed directly
- A: depends on support and complexity; bi-partisan support is best to get action
- Claudia: who is in charge of omnibus bills?
- A: chair works with members
- Claudia: there are authors and co-authors of bills; what is the responsibility of the co-authors?
- A: co-authors generally show support for the bill's ideas rather than actual work; can pull name if not agreeing
- Claudia: what do chief authors do?

- A: must ask for hearing from Chair and Chair decides whether to hear or not; responsible for presenting bill and garnering support
- Authors typically have help from another body
- NAMI preps authors with testifiers and information to speak to
- Claudia thanks Elliot for an informative presentation

- V. Jode Freyholz-London introduces Rep Peter Fischer to give an update on Day on the Hill activities -12:00 12:10 (12:03)
 - Rep Fischer is in attendance but not prepped for this discussion so this is tabled for later meeting

VI.Workgroup updates - Claudia Daml - 12:10-12:30 (12:05)

- Claudia asks chairs to give updates on next steps from recommendations
- Integrated care and access Mary Kjolsing = Chair had 4 recommendations
 - Develop comprehensive needs assessment data bank for MN Susan Hasti trying to connect with Diane Neal (DHS) but have found this difficult; she is onboard with this goal; expect with time to develop relationship to get detailed structure of what this might look like to better advocate for this
 - To look at MH needs across the state and determine who's getting/not getting services and identify gaps in terms of infrastructure and placement; to be more proactive for funding
 - Reimbursement rates: Claudia equity piece to bring up MH rates for sustainable services; DHS made recommendations last year; legislative bills = SF1402 and HF1005; hope to support in round 2
 - Prior authorization reform Rakesh different insurance companies have different practices; difficult to find much information on this; asking to prohibit this for psychiatric conditions and disorder treatment; was expanded last year for non-medication treatments for MH emergencies and disorder treatment; doesn't apply to medications; also want way to report and monitor approaches; requirement by utilization to MDH in terms of approval and denial data; medications remain
 - Will need support from Medical Assn to further
 - Collaborative Care Management: Dr. Trangle = not in attendance today;
 Claudia saw HF958 has been created; can track my bills to be notified of actions; elevating psychiatric collaborative care model; NAMI is supporting this and it has been approved in both bodies
- LACs Sierra Grandy 3 recommendations
 - Expanding communities
 - Revise statute to use person-1st language
 - Equity between adult and children language in statutes
 - Updating Global Advisory Councils handbook to include useful information and best practices and resources to share among LACs
 - Yesterday's meeting had 20+ members attend; meet Wed before Council; trying to make a difference



- Next meeting April 2nd 3:30 4:30
- LACs are county advisory councils mandated by statute
- Recommendations need legislative action
- Aren't taking steps to advocate at that point right now
- Helping to develop better understanding of county's overall MH funding and develop needs assessments; varies greatly throughout MN
- Some counties work regionally; not much cohesion or teeth to statute for those that don't follow through
- Hoping that resources will make it easier for LACs to be active
- Email Sierra with questions ccgrandy@gmail.com
- MH and Juvenile Justice Elliot Butay
 - one recommendation was to get MH services in detention centers; have bill (no number) but is slow in the process; not much money to support; if this doesn't proceed, may have working group to discuss how to fund these services;
 - Corey reaching out to Rep Feiss about data recommendation as she's Corey's rep and very into data
 - Competency attainment for juveniles is another recommendation; last year bill
 raised age from 10 to 13; this hasn't gone into effect yet; another bill is up to
 return age; efforts are in place to delay this bill
- MH Awareness at the Mn State Fair Dave Lee
 - Update in chat: details available in April's meeting
 - Hold the day Aug 25th 2025 on caledars
- Amy Jones will give update on MH in Schools at next meeting (has left meeting)
- Family Systems, Intervention or Supports Anna Lynn no current updates
 - May consider merging with another workgroup
- Recovery Supports not currently meeting Angie and Gary Travis were only 2 attending meeting; struggling with attendance
- Outreach to Diverse Communities Dr B
 - Thanks Lisa for this morning's discussion on DEI in the Children's Subcommittee; many agencies are being paralyzed by recent funding and administrative decisions
 - Sees every member as a MH leader; need to know how to situate equity, diversity and inclusion palatably to be taken up
 - Need strategies to infiltrate areas where diversity isn't welcome; need to develop strategies for this
 - Trying to position work so that every member owns diversity work
 - Claudia will reach out to Dr. B about speaking at next month's meeting

 - DOC Shanna Langston/Holly Hanson –
 - DHS Diane Neal and Kristine Preston Teresa Steinmetz (AC DHS)
 - Regarding uncertainty about federal funding messaging



- DHS doesn't often know more than what is being reported in the media
- DHS' mission continues to improve lives of MNs
- Temporary Commissioner Ghandi has been promoting these messages
- Haven't had to implement any changes regarding DEI work
- Release of executive orders is creating fear and uncertainty and will continue work until they hear otherwise
- Dept has legal obligation to provide a safe, inclusive workplace;
- Federal level changes are constant; DHS leadership group meets daily to examine changes and implications
- Suspension of federal funding would have huge impacts and real consequences to DHS and the people they support
- Trying to understand what's coming out and identify impacted programs
- Major changes relating to Medicaid program would also be devastating
- DHS sent out new materials to inform discussions about state public healthcare programs; 3 fact sheets available
- Want to address misconceptions with facts on services and #s of people impacted
- DHS is doing all they can to mobilize and understand; workforce changes have impacted hearing answers in the regions making this more challenging
- Met today with leaders of Children's Subcabinet
- Kristine Preston: discusses block grant work and planning process being improved
- Included link in chat https://mn.gov/dhs/medicaid-matters/
- New application for this year not yet released by SAMSHA; may see more changes based on federal action; final application unlikely to be available until summer and due Sep 1
- Have done strengths and needs assessment including public engagement to identify gaps
- Want to address this group again in May to engage in further discussion and feedback
- Have multiple stakeholder initiatives to collect, validate data and submit by end of summer
- Block grant applications don't address every need
