Meeting Minutes for July 18, 2025

Call to order

Facilitator Stacy Sjogren and Chair Joe Clubb began the meeting at 11:00 am, reviewed the OERAC mission, the meeting ground rules and gave a guest welcome. The meeting agenda was confirmed, and a roll call followed. Quorum was secured. See voting log for details.

Business items

Minutes approval: Kristi Schoen moved to approve the minutes from the May 16, 2025 meeting. Seconded by Charles Reznikoff. Motion passed with roll call vote. See voting log for details.

New Council Member Welcome: Abdirahman Warsame joins the council as the member in opioid recovery. He is co-founder of Generation Hope. The Council welcomed him to the group.

Facilitator Change: Stacy Sjogren is welcomed back as the main facilitator for OERAC.

RFP Important Items: OERAC 2024 grantees and the Opioid Response Settlement Dashboard are updated. The OERAC 2025 RFP was open and there was a call for Community Reviewers for the OERAC 2025 RFP.

Council Open Seats: Three OERAC seats were open for applications on the Office of the Secretary of State's website:

- Licensed Opioid Treatment Program, Sober Living Program, or Substance Use Disorder Program Representative
- Public Member with Chronic Pain, Intractable Pain or Rare Disease or Condition
- Alternative Pain Management Therapies Representative.

Noted by Council that "Sober Living Program" language should be changed.

OERAC Leadership Nominations: OERAC Chair and Vice Chair nominations will open in August and be selected in October.

Tribal Consultations: Joe Clubb, OERAC Chair, noted that Tribal Consultations are currently happening. The OERAC Chair and Vice Chair are the representatives for OERAC that attend the consultations.

Public Comment

OERAC Chair, Joe Clubb, welcomed public comment at 11:20AM.

- Yussuf Shafie, Founder of Alliance Wellness Center, spoke about the burden of addiction on communities, particularly the Somali community in Minnesota. He emphasized that addiction and recovery can look different across communities. While many people are in recovery, stigma continues to persist. He noted that minority communities are often left behind in terms of resources and services. He expressed support for Abdirahman's appointment to the Council and called for partnership and commitment to continue this work.
- Mohamed Ahmed, who is in recovery, shared his personal journey. He described recovery as allowing him to live a full life, noting he tried many different avenues before finding success in recovery with people who shared his lived experiences and background. He highlighted the heavy impact of the opioid crisis on the East African community and the role stigma and shame play in preventing people from seeking help. He shared the story of a women seeking a recovery program specifically for women but finding no resource available.
- Adan Hassan, an alumni member of Alliance Wellness Center, spoke about the importance of culturally specific treatment centers. He felt entering treatment was easier when he felt comfortable and supported by people who understood his background and needs. He also emphasized the importance of ongoing support after recovery. He called for more resources dedicated to messaging and outreach to alert people of the available treatment programs.
- Jeff Missling, Founder and CEO of Frenelle Pharma, a pharmaceutical company based in Plymouth, MN, shared information about his company's work. Frenelle Pharma aims to develop a safer, accessible, and cheaper version of Sublocade and Brixadi.
- Hanna Kazempour, employee at Change the Outcome, provided information that the organization is hiring young people, in recovery or impacted by loved one's substance use, that are interested in participating in their school education programs.

 Kylie Komaridis spoke about need for diversity of organizations receiving grant contracts and need for follow up on the organizations receiving large grants.

Prescription Monitoring Program Update

Brock Reed, OERAC representative for the Board of Pharmacy, presented an update on the Prescription Monitoring Program (PMP). The PMP's purpose is intended to aid in clinical decision making and minimize prescription drug abuse. All dispensed controlled substance prescriptions are reported to the PMP, which is then used as a clinical tool for prescribers and pharmacists when providing patient care.

Council Education: Conflict of Interest

Kristine Preston, DHS Deputy Assistant Commissioner for the Behavioral Health Administration, presented information on Conflict of Interest. She reviewed relevant Minnesota statutes, OERAC bylaws, and the definitions of conflict of interest. The Council Members then participated in case scenario discussions.

OERAC Chair Joe Clubb adjourned the July 2025 meeting.
