## **Regulation Modernization**

The Child Care Regulation Modernization Project aims to create consistency throughout the state on licensing actions, allow eligible programs shorter inspections for outstanding performance, and modernize outdated licensing language. The project has three components:

- Risk-based tiered violation system (also known as the Weighted Risk System)
- Abbreviated inspections (also known as Key Indicator System)
- Revised licensing standards

## Legislative session updates

Each legislative session provides an opportunity that there may be requirement changes or updates for licensed child care centers.

When updates need to be communicated, the DHS Licensing Division sends out communications via the govdelivery system. In addition, an implementation plan is developed and shared with licensed child care centers, explaining how changes may apply to them.

The <u>Child Care Center Licensing webpage</u> has a section that shares information on <u>legislative changes</u> and includes the current implementation plan and an archive of plans from past years for reference.

During the legislative session, <u>Child Care Aware Minnesota</u> offers a weekly <u>Bill Tracker</u> that summarizes the progress of bills and other news related to early care and education and school-age care.
