<u>Citizen Review Panel Purpose and Founding federal law for panels:</u> Child Abuse Prevention & Treatment Act (CAPTA) states, "Each panel...shall, by examining the policies, procedures, and practices of the State.

<u>Minnesota Statutes, section 256.01, subdivision 15</u> states that panels "examine the policies and procedures of state and local welfare agencies to evaluate the extent to which the agencies are effectively discharging their child protection responsibilities."

<u>Chisago County CRP mission:</u> "To provide an opportunity for citizens to play a role in ensuring children are protected from abuse and neglect, and to encourage and help build nurturing homes for children in our communities."
