#### **Meeting Minutes**

- Welcome and introductions
- Panel Leadership Updates

-Community members (Carol S. Deb K. Karen K. and Nancy) met on March 2023. Carol S. was elected as the chair of the Chisago CRP.

- Maltreatment reconsideration discussion:
  - December reconsideration: finding was upheld by panel and county
  - Resume practice of having post-reconsideration discussion at panel meetings following panel review of reconsideration.
  - The reconsideration case was completed by the panel was an ICWA case.
  - Discussed ways to identify conflict of interest earlier on in the process.
  - Vicki provided the Minnesota Child Welfare Data Dashboard. The Child Welfare Data Dashboard is intended to provide information to the public as well as county and tribal decisionmakers on nine state measures and seven federal measures used to monitor the status of children served by Minnesota's child welfare system. The measures are separated into two distinct dashboards: One for state measures and another for federal measures. Although the dashboards use different measures and performance standards, they were designed to present information in parallel ways.

- Vicki discussed information about Eco-maps, like genograms are a visual tool that can provide very useful information for workers and clients in the process of developing case plans. Ecomaps are a visual map of a family's connections to the external world. This tool is what case workers in Minnesota child protection agencies use to identify family connections. It is especially important when working with an ICWA/MIFPA case.
- Panel project discussion of Purpose/scope
  - Founding federal law for panels: <u>Child Abuse Prevention & Treatment Act</u> (CAPTA) states, "Each panel...shall, by examining the policies, procedures, and practices of State

and local agencies and where appropriate, specific cases, evaluate the extent to which State and local child protection system agencies are effectively discharging their child protection responsibilities..."

- <u>Minnesota Statutes, section 256.01, subdivision 15</u> states that panels "examine the policies and procedures of state and local welfare agencies to evaluate the extent to which the agencies are effectively discharging their child protection responsibilities."
- Minnesota CRP *mission*: "To ensure Minnesota's child welfare systems are protecting children"
- Chisago County CRP *mission*: "To provide an opportunity for citizens to play a role in ensuring children are protected from abuse and neglect, and to encourage and help build nurturing homes for children in our communities."
- Minnesota CRP *vision*: "Community members are powerful partners in shaping local and statewide child welfare policy and practice."
