Earlier this week the U.S. House Agriculture Committee, which oversees SNAP, released its plan to cut roughly \$300 billion from SNAP over the next ten years. The plan includes many deeply concerning changes that would reduce the value of SNAP to pay for groceries, cause many Minnesotans to lose access to SNAP, and shift hundreds of millions of dollars in costs from the federal government onto Minnesota. Here's a brief break-down of some of the major changes in the current text of the House bill:

- Forcing states to pay a share of benefit costs. The bill forces states to pay a share of SNAP benefits, which would be based on state "payment error rates" and could range from 5% to as much as 25%. Shifting 25% of SNAP benefit costs onto Minnesota could cost taxpayers about \$220 million per year.
- Reducing federal reimbursement of state administrative costs. The bill forces states to pay more to administer SNAP, cutting the federal reimbursement rate that state,

- local, and Tribal governments, and community-based organizations, receive for administering the program in half another major cost shift onto Minnesota taxpayers.
- Expanding work requirements to older Americans. The bill expands the "time-limited recipient" work requirements to encompass older adults, increasing the age of the work requirements from the current 18 to 54 to 18 to 64. These older adults would now only qualify for 3 months of SNAP if they don't comply with the work requirements.
- Imposing work requirements on families with children.
  The bill also, for the first time, imposes the "time-limited recipient" work requirements on families with dependent children, exempting only families with children under age 7 or who qualify for an exemption (such as being married to someone complying with the work requirements).
  Previously, "dependent children" were defined as children under age 18.
- Expanding the "general work requirements." In addition to expanding the 80 hours per month work requirements placed on "time-limited recipients," the bill also expands the "general work requirements" age from over 15 and under 60 to over 17 and under 65.
- Restricting state flexibility for work requirement waivers and exemptions. The bill eliminates state flexibility to apply for waivers of the work requirements for areas lacking sufficient jobs, making those waivers available only to counties with unemployment rates of 10% or more and not for more than 12 consecutive months. The bill also greatly restricts state discretion to exempt a portion of SNAP recipients not living in a waiver area from the work requirements.
- Limiting updates to the Thrifty Food Plan. The bill limits
  future updates to the "Thrifty Food Plan," which forms the
  basis for calculating SNAP benefit amounts a change
  that will reduce the value of food benefits and make it
  more difficult for families to pay for groceries.
- Restricting household utility deductions. The bill restricts how everyday household expenses, such as internet and energy utility costs, can be used as deductions from a family's income to help increase their food benefits.
- Restricting SNAP eligibility for legal non-citizens. The bill limits SNAP benefits to only individuals who are citizens or lawful permanent residents of the United States. Other categories of legal non-citizens, such as refugees, asylees, and victims of human trafficking, among others, will no longer be eligible for SNAP benefits.
