- **SLF** Supervised living facility
- **SOCCPN** Sex Offender Civil Commitment Program Network (national organization of 20 state {and one federal} civil commitment programs, summit held annually).
- **SOS** State Operated Services former name of DCT prior to 2014 (still in documents and statutes).
- SRB Special Review Board
- **Subd. 7** a report regarding someone's competency to participate in their criminal proceedings, comes from Rule of Criminal Procedure 20, report is typically produced every 6 months unless otherwise specified by the court
