Meeting Notes

Reflections on Individual and Families Stories Shared

- I. Task force members affirmed the value of stories in guiding recommendations and ensuring families feel heard.
- II. Consensus to include a section in the final report that reflects on family contributions and outlines how their input shaped recommendations.

Recommendations from Workgroup 1 and 2

- I. Workgroup 1 (Objectives 1 and 2)
 - a. The workgroup reviewed national trends in indefinite commitment and state civil commitment statues
 - i. Nationally, there has been a 76% increase in forensic inpatient populations.
 - ii. Referrals for MI&D (Mentally III and Dangerous) admissions across the DCT (Direct Care and Treatment) system increased by 110% between fiscal years 2015 and 2024.
 - iii. Prior to 2019, a dedicated competency restoration program existed within the Forensic Mental Health Program (FMHP) for Rule 20 patients.
 - iv. After 2019, those beds were absorbed into the broader FMHP (Forensics Mental Health Program) to accommodate the growing MI&D population.

- II. Workgroup 2 (Objectives 5 and 6)
 - a. Focused on improving the assessment and evaluation process to prevent inappropriate MI&D commitments.
 - b. Proposed the creation of:
 - i. A dedicated assessment and stabilization facility (state-operated, secure, and regional).
 - ii. Regional state-run residential settings that meet varying levels of support needs.
 - c. Recommended expanded access to transitional care settings, consistent funding for county case management, and better discharge planning to avoid unnecessary revocations.
 - d. Supported the need for flexible and person-centered residential options, potentially modeled after successful programs like Rising Cedars and Life Bridge.
