Discussion on the 48 Hour Rule

- I. General agreement on the potential 3-year suspension of the 48-hour rule, contingent on establishing proper benchmarks and investments
 - a. Benchmarks discussed include monitoring timelines from diagnosis to treatment
 - b. Discussion on whether 48 hours is a medically appropriate benchmark
 - c. Questions posed about defining an appropriate timeframe and ensuring accountability
 - d. Agreement on the need for better understanding of the rules impact during a suspension period
 - e. Proposed developing a public report for stakeholders, quantifying data to provide clarity on DCT performance and support
 - f. Explore alternative timeframes and their accountability mechanisms
 - g. Develop a data dashboard for real-time public reporting
 - h. More Intensive Residential Treatment Services (IRTS)
 - i. Address gaps in mental health support with community involvement
 - j. Recommendations to better utilize Medicaid and explore outpatient mental health services in jails
