Pib thaum Lub Kaum Hli Ntuj Xyoo 2026 mus, daim Federal Reconciliation Bill (H.R.1) uas President Trump (Thawj Tswj Hwm) tau kos npe pom zoo ua cai rau xyoo 2025, yuav coj qee yam cai tshiab ua yuav tsum muaj rau Medicaid.

Medicaid yog ib hom kev duav roos pov hwm kev kho mob ua muaj lub npe hu ua Medical Assistance (Tsoomfwv Kev Pabcuam Rau Kev Kho Mob) nyob rau hauv lub xeev Minnesota.

Yog koj xav paub txog cov xov xwm tshaj tawm tshiab, thov mus xyuas lub website no lossis thaj daim QR Code no, lossis mus xyuas lub website mn.gov/dhs/federalchanges. Thov khaws lub website no thiab nco ntsoov xyuas cov xov xwm tshiab ua lawd tau tso rau hauv.
