

**DHS is seeking to provide prepaid health care services to eligible individuals through the Families and Children Medical Assistance and MinnesotaCare contracts in the following counties: Anoka, Carver, Dakota, Hennepin, Ramsey, Scott, and Washington.**

DHS, through its Purchasing and Service Delivery (PSD) Division, is seeking proposals from qualified responders to provide prepaid health care services to eligible individuals through the Families and Children Medical Assistance (MA) (the State's Medicaid program) and MinnesotaCare (the State's Basic Health Program [BHP]) contracts in the following seven (7) counties: Anoka, Carver, Dakota, Hennepin, Ramsey, Scott and Washington.

All Responders must meet the requirements as referenced in section 1.3 (7) Qualified Responders. Currently contracted Managed Care Organizations (MCOs) must respond to this RFP to be considered for selection to continue providing benefits through the Families and Children Medical Assistance and MinnesotaCare contract in the seven counties listed previously.

The term of any resulting contract is anticipated to be for one (1) year, from January 1, 2022, until December 31, 2022. Thereafter, the State may choose to renew any contract awarded under this RFP annually for up to five (5) years, in accordance with Minnesota Statutes, section 16B.98 subdivision (5)(b). The State reserves the right to initiate a new procurement whenever it becomes necessary.
