Presentation on DHS' Personal Health Records (PHR) for Long-term Services and Supports Demonstration (aka Testing Experience and Functional Tools grant [TEFT])

Q: Is it possible to delve deeper in the PHR than the program level a person is on, for example, to see what services and number of units of the services a person is receiving?

A: No, the effort with this project was to prove the ability to put any information out there to allow people to see it. Because of that, we put out a very simple profile page to test the proof of concept. That said, the goal would be to ultimately make a lot of information available to beneficiaries electronically. This grant work is the first step in the process towards achieving that goal.

Q: Are there lessons learned from this grant project that might be able to be used for other projects?

A: Yes, we've learned a lot of lessons from this project that we're sharing across the department. Ultimately, it would be great to have a beneficiary portal where people can log in to see a lot of different pieces of information. When implemented, this grant project will hopefully help to make the launch of the portal more successful.

Q: Can you speak to how data privacy concerns are addressed with this project? (This came up in several comments and questions.)

A: Privacy is always a priority. The project included the development of security protocols. Any exchange of health care information would be subject to applicable laws and regulations governing such exchanges.

Q: Are people allowed to opt out of having their records shared? There should be a high standard for what constitutes giving consent to have your records shared. It seems like coercion to make one's ability to get care dependent on consent to share information.

A.: There is already a process for asking people to give consent to share their health information. People are informed that it might impact their ability to get care if they don't consent to having their records shared.
