Annual Health Plan Selection (AHPS) Notice

Dear JANE J PUBLIC,

You are currently enrolled in UCARE Minnesota Senior Care Plus (MSC+). You are eligible to change your health plan for January 01, 2024 as part of Annual Health Plan Selection (AHPS). **If you want to keep your current health plan, you do not need to return this notice.** If you want to change your health plan, continue reading this notice.

MSC+ is a mandatory managed care program that administers your Medical Assistance health benefits through a health plan. You receive your Medicare benefits separately. Information on your MSC+ choices is as follows.

If there are other members of your household enrolled on Minnesota Health Care Programs, they will receive a separate AHPS Notice.

Information about your health plan choices

You are currently enrolled in MSC+

What this program does:

- You get Medicare Parts A and B services through Original Medicare and prescription drugs through a separate Medicare Part D plan.
- **If you want to keep your current plan, you do not need to return this notice.**

You have another choice:

Minnesota Senior Health Options (MSHO)

What is MSHO?

- You would get your Medicare and Medical Assistance health care services coordinated through the same health plan.
- You would have access to a care coordinator to help you plan your care.
- You would get additional benefits that are not available through regular Medical Assistance.
- There are no additional costs for enrolling.
- **If you want to enroll into MSHO, you will need to complete a separate enrollment form and return it to the health plan by December 01, 2023. Use the MSHO health plan contact information in this letter to contact a health plan that is available to you and request an enrollment form.**

Note: When choosing a health plan, you may want to ask your providers if they are part of the health plan. Or you can refer to the health plan provider directories and other resources on the AHPS website at <https://mn.gov/dhs/health-plan-selection/>.
