Combination items, such as TV/DVD combinations, count as one of each item.

Battery-operated projecting lights, Wi-Fi capability, and the ability to monitor or record vocals to an allowable media source (e.g. internal memory, CD, etc.) are all prohibited

Functional digital media ports, USB ports, SD slots, and media card slots that can transfer media must be tamper-sealed.

Hobby Craft: Pages 14-17

Hobby items requiring storage in the Recreation Department must receive pre-approval from the Recreation Department prior to ordering. Recreation Department-stored items not receiving pre-approval are placed on a Contraband Notice (420-5250b).

Clients may only work on hobby craft items in their rooms with unit team approval or if that item could be kept in their room once completed per MSOP Division Policy 420-5250, “Client Property”.

Medical Equipment: Page 17-18

All items on this list must have Health Services approval prior to ordering. Approved Health Services Equipment will be documented in Clients Accommodations in Phoenix. All medical equipment must be ordered from and delivered new from a vendor.

All other requests for medical equipment are to be submitted to the Health Services Case Manager via a Client Medical Request (310-5010e) for review and final approval by the Allowable Items Workgroup (AIW).
